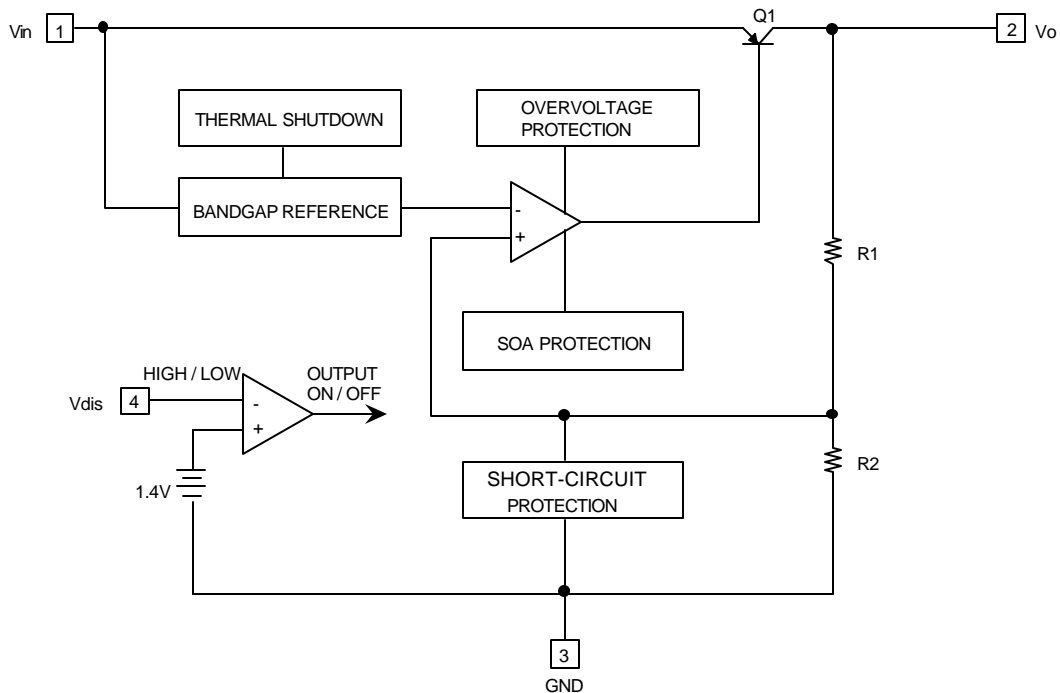

This regulator has various function such as peak current protection, thermal shut down, overvoltage protection and output disable function.

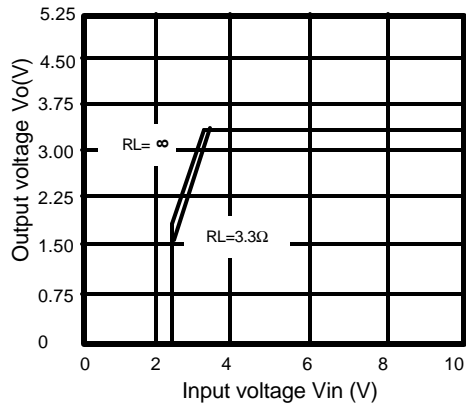


Figure 1. Output Voltage vs. Input Voltage

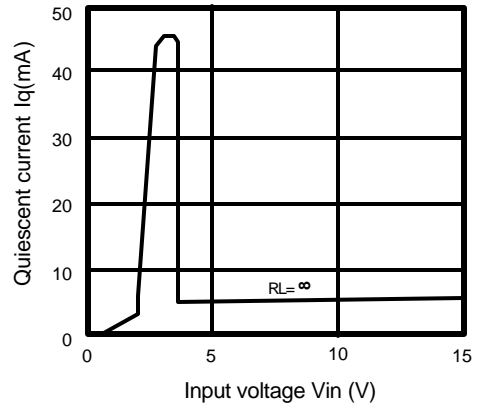


Figure 2. Quiescent Current vs. Input Voltage

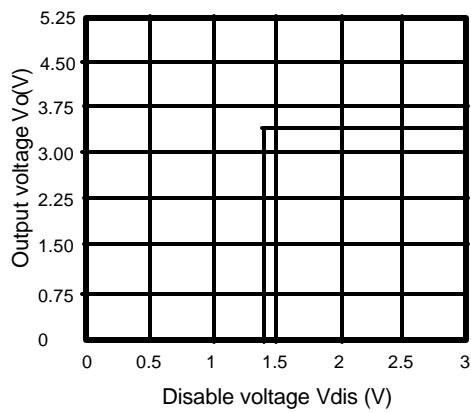


Figure 3. Output Voltage vs. Disable Voltage

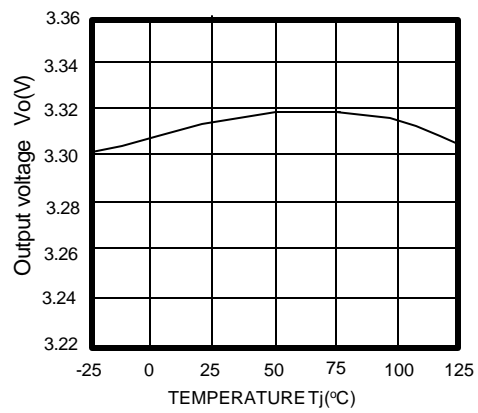


Figure 4. Output Voltage vs. Temperature(Tj)

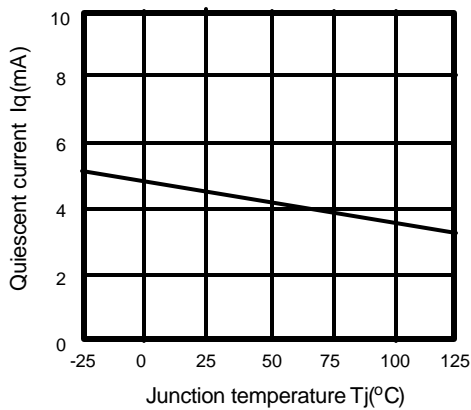


Figure 5. Quiescent Current vs. Temperature(Tj)

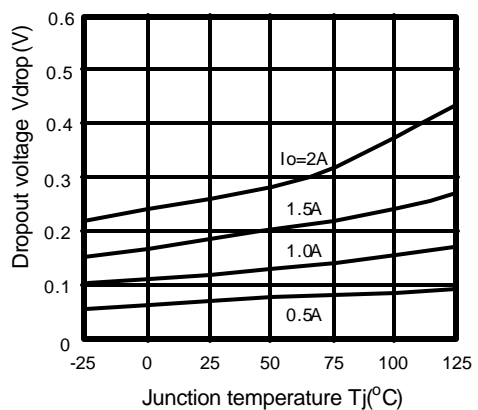


Figure 6. Dropout Voltage vs. Junction Temperature

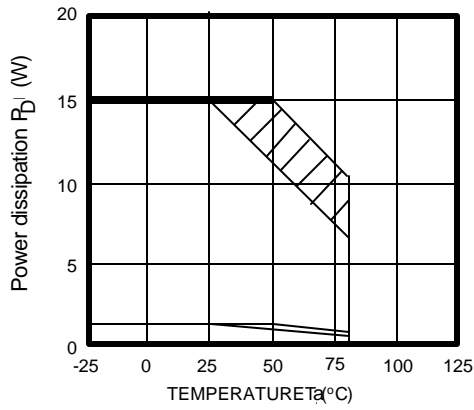


Figure 7. Power Dissipation vs. Temperature (T_a)

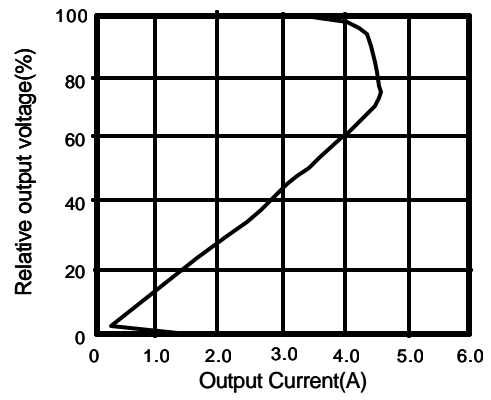


Figure 8. Overcurrent Protection Characteristics (Typical Value)

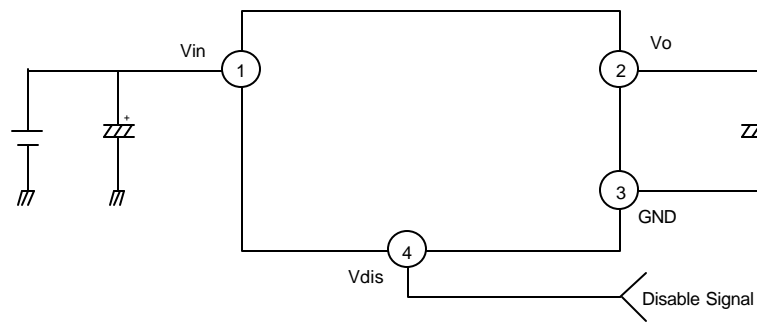


Figure 1. Application Circuit

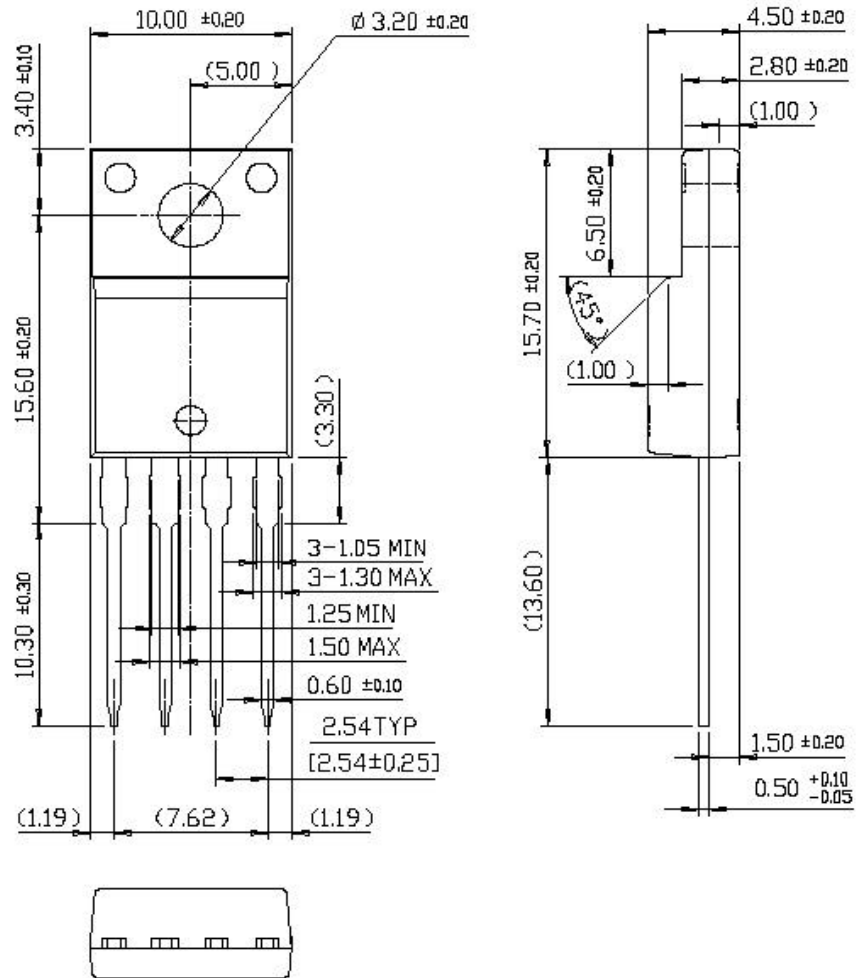
- C_i is required if regulator is located an appreciable distance from power supply filter.
