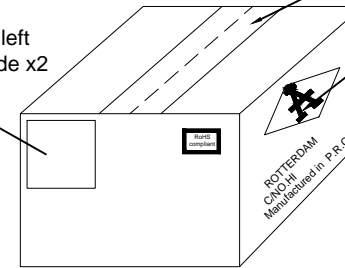
Packing information:
