






Fig. 8.1 Marking RN1310





Fig. 8.2 Marking RN1311




Fig. 9.7 RN1310 V<sub>CE(sat)</sub>-I<sub>C</sub>

Fig. 9.8 RN1311 V<sub>CE(sat)</sub>-I<sub>C</sub>


