# TC74VCX157FT

### 1. Functional Description

· Low-Voltage Quad 2-Channel Multiplexer with 3.6-V Tolerant Inputs and Outputs

#### 2. General

The TC74VCX157FT is a high performance CMOS multiplexer which is guaranteed to operate from 1.2 V to 3.6 V. Designed for use in 1.5 V, 1.8 V, 2.5 V or 3.3 V systems, it achieves high, speed operation while maintaining the CMOS low power dissipation.

It is also designed with over voltage tolerant inputs and outputs up to 3.6 V.

It consists of four 2-input digital multiplexers with common select and strobe inputs.

When the  $\overline{ST}$  input is held "H" level, selection of data is inhibited and all the outputs become "L" level. The SELECT decoding determines whether the A or B inputs get routed to their corresponding Y outputs.

All inputs are equipped with protection circuits against static discharge.






Fig. 12.8.1 t<sub>PLH</sub>, t<sub>PHL</sub>


