



FIG 4 (ERM5-030-02.0-X-DV-WT SHOWN) (SAME AS FIG 3) (NOT AVAILABLE WITH -FL)






FIG 3 (ERM5-030-02,0-X-DV-FL SHOWN) (SAME AS FIG 1 EXCEPT AS SHOWN) (NOT AVAILABLE WITH -WT, ONLY AVAILABLE UP TO 30 POSITIONS)






FIG 2 -K OPTION (USE K-DOT-.138-.250-.005) (ERM5-030-02.0-X-DV-K SHOWN)





FIG 7 (ERM5-030-02.0-X-DV-L SHOWN) (SAME AS FIG 1 EXCEPT AS SHOWN) NOT RELEASED
