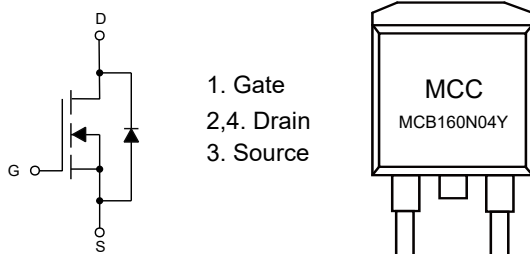

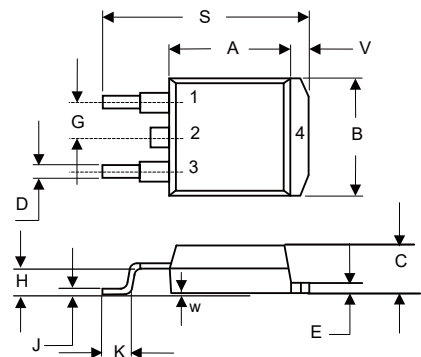

Internal Structure and Marking Code



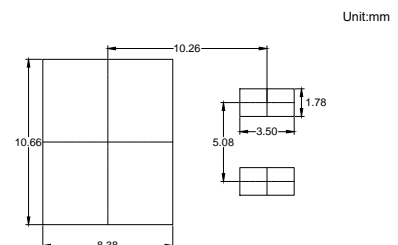

Fig. 1 - Typical Output Characteristics

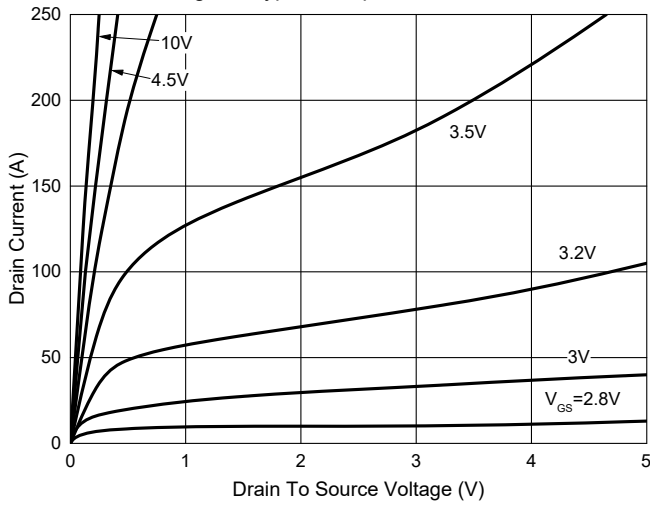


Fig. 2 - Transfer Characteristics

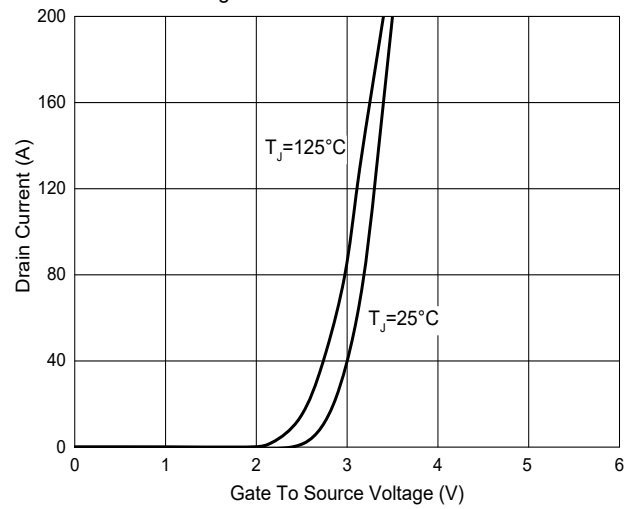


Fig. 3 - R_{DS(ON)} - V_{GS}

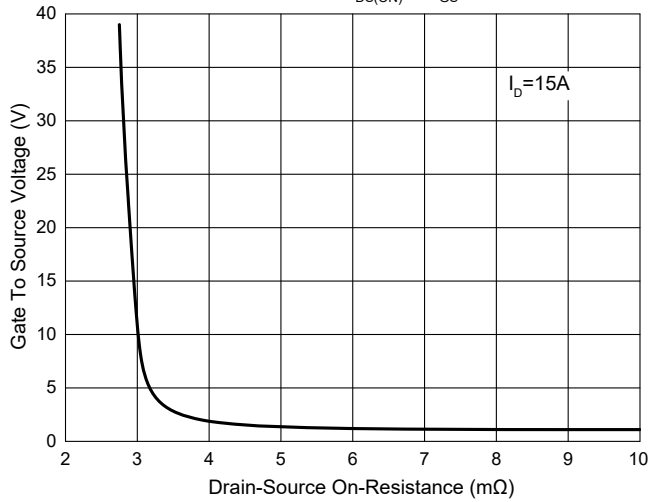


Fig. 4 - Drain-Source on Resistance

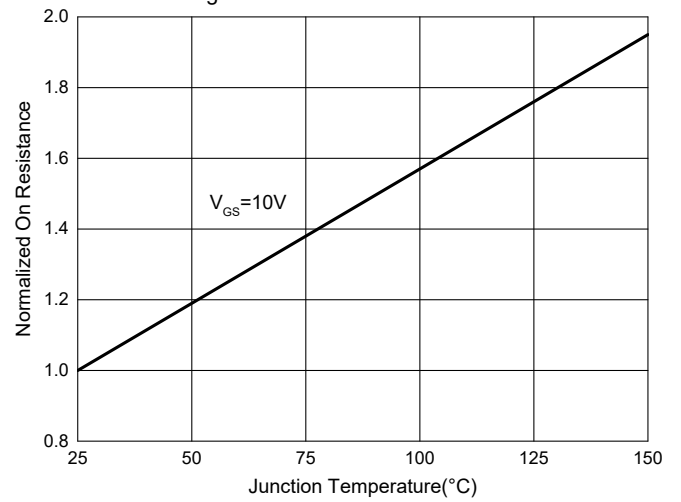


Fig. 5 - Capacitance Characteristics

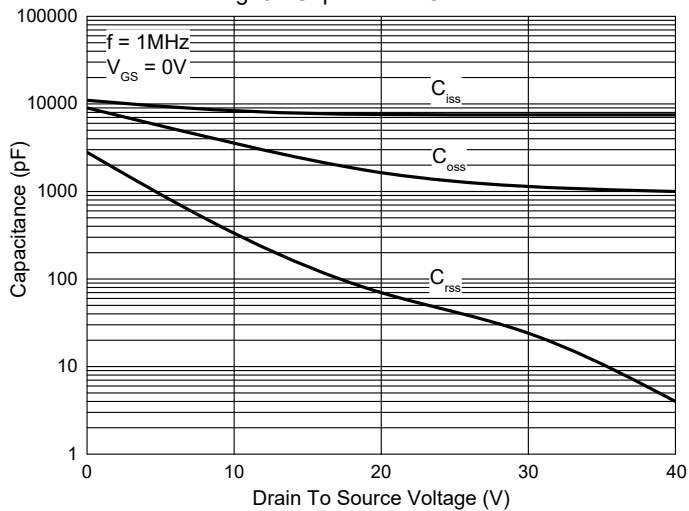
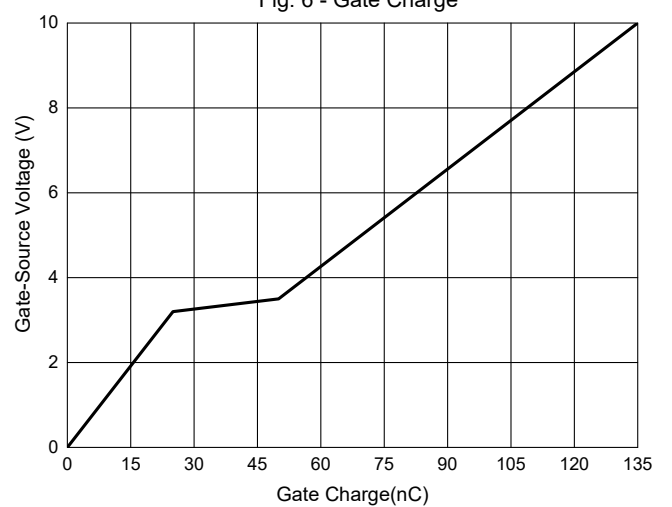


Fig. 6 - Gate Charge

Fig. 7 - Safe Operation Area

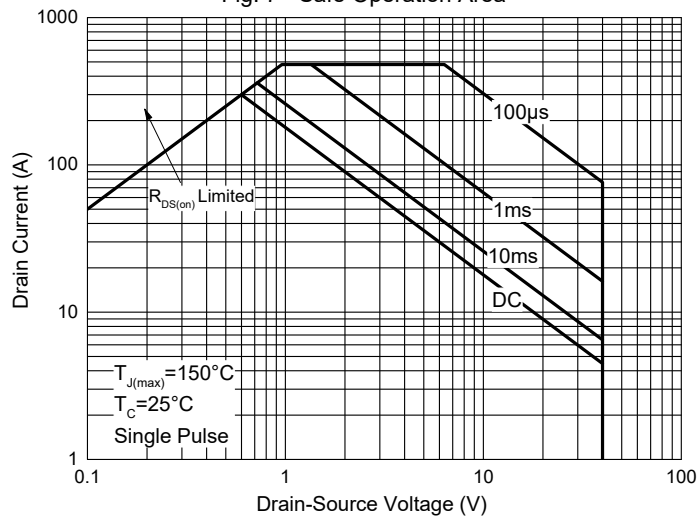
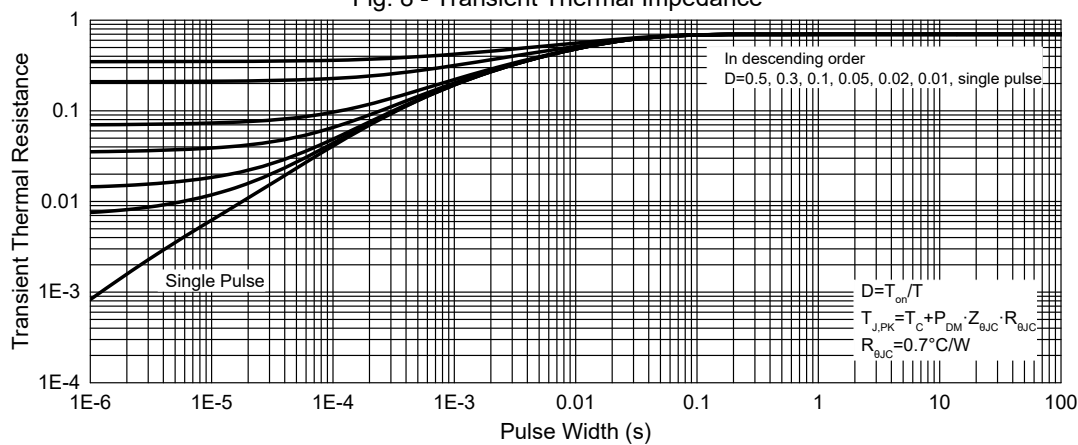


Fig. 8 - Transient Thermal Impedance
