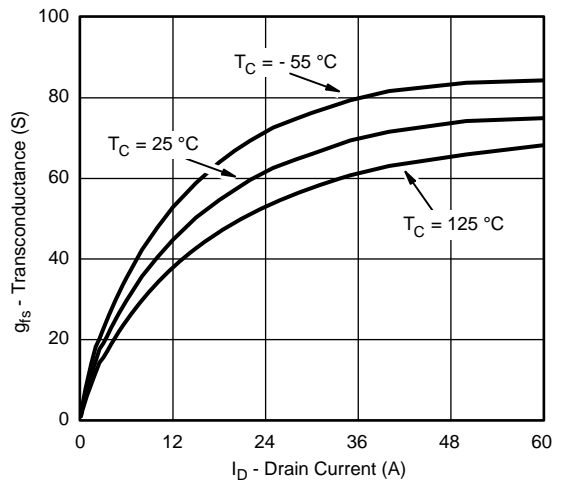

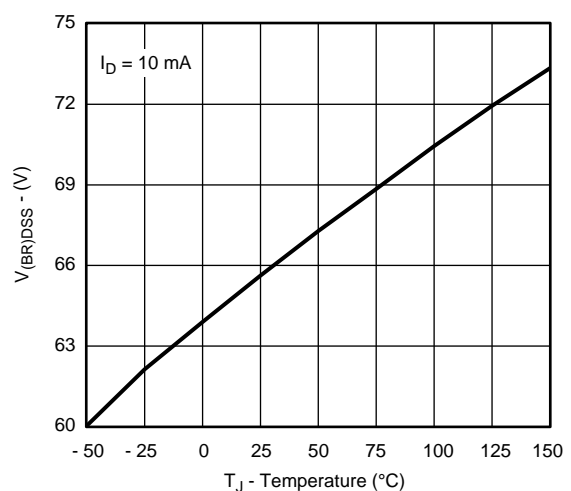
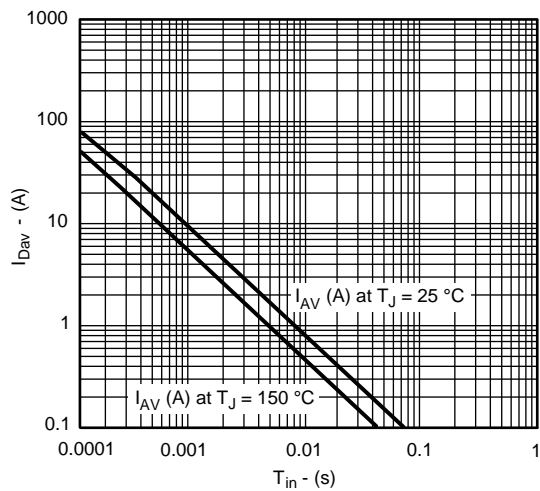
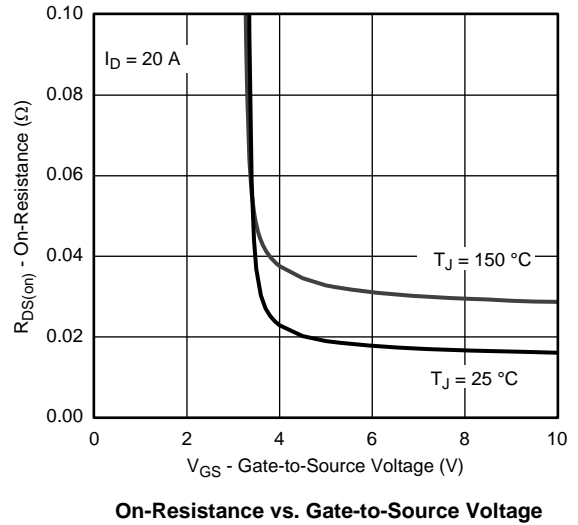
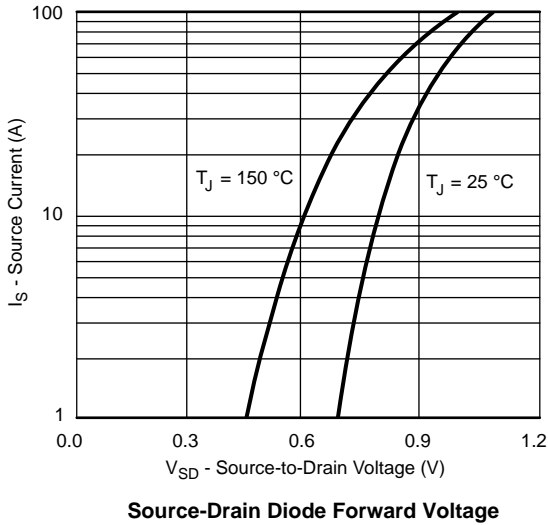
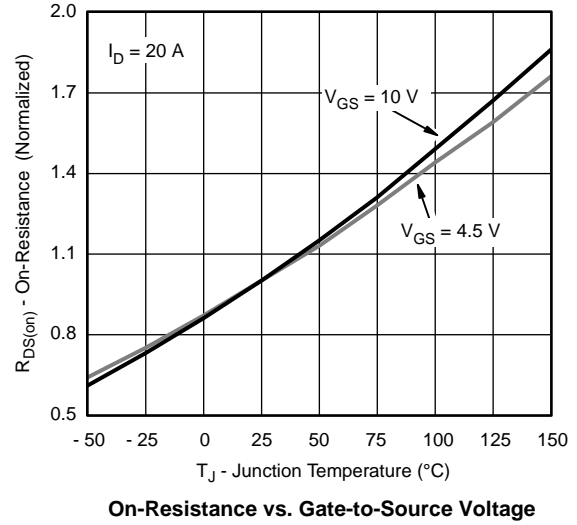
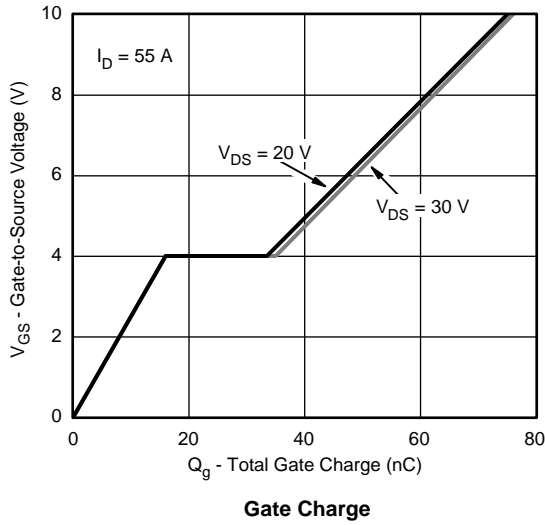


On-Resistance vs. Drain Current



Capacitance

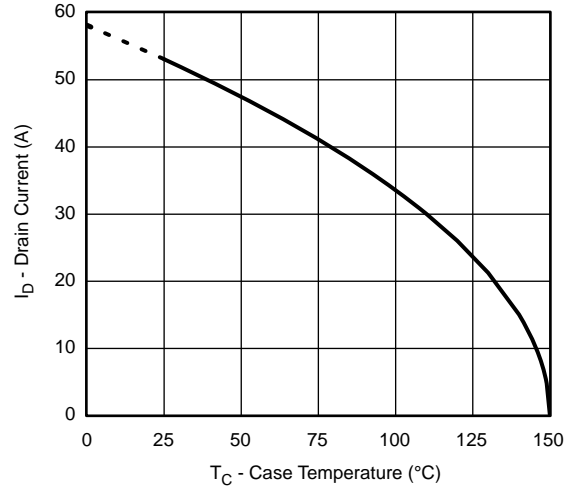

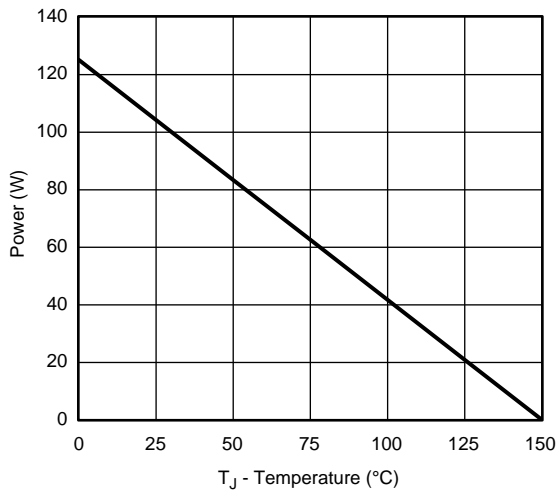

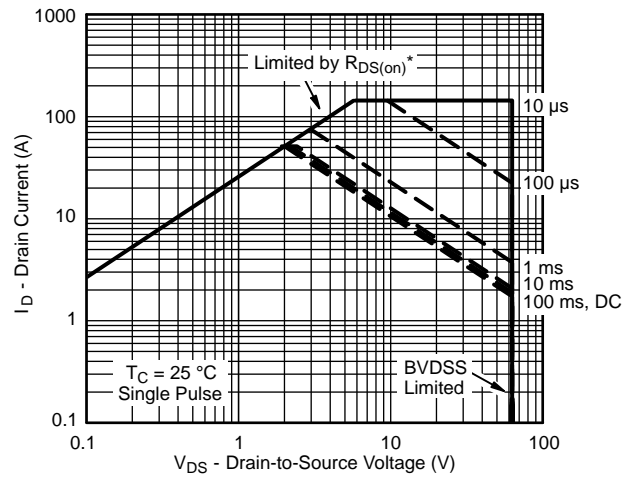
Threshold Voltage
