






Fig. 13.3 Q1 I<sub>C</sub>-V<sub>I(OFF)</sub>




Fig. 13.5 Q1 h<sub>FE</sub>-I<sub>C</sub>




Fig. 13.2 Q2 I<sub>C</sub>-V<sub>I(ON)</sub>




Fig. 13.4 Q2 I<sub>C</sub>-V<sub>I(OFF)</sub>





Fig. 13.6 Q2 h<sub>FE</sub>-I<sub>C</sub>








Fig. 13.7 Q1 V<sub>CE(sat)</sub>-I<sub>C</sub>


Fig. 13.8 Q2 V<sub>CE(sat)</sub>-I<sub>C</sub>
