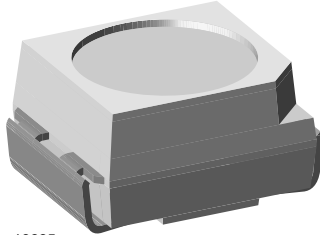

The package of the VLME31-series is the PLCC-2.

It consists of a lead frame which is embedded in a white thermoplast. The reflector inside this package is filled up with clear epoxy.

- The above type numbers represent the order groups which include only a few brightness groups. Only one group will be shipped on each reel (there will be no mixing of two groups on each reel).
- In order to ensure availability, single brightness groups will not be orderable.
- In a similar manner for colors where wavelength groups are measured and binned, single wavelength groups will be shipped in any one reel.

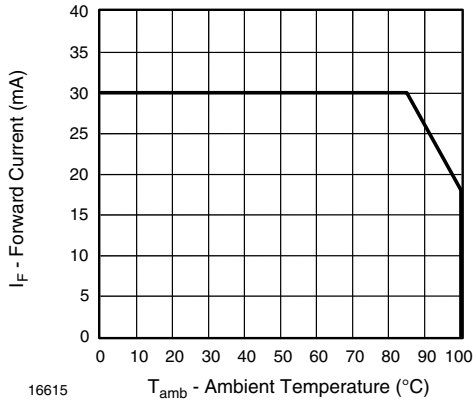


Fig. 1 - Forward Current vs. Ambient Temperature

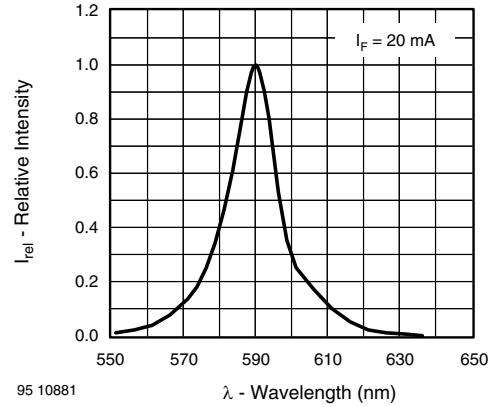


Fig. 4 - Relative Intensity vs. Wavelength

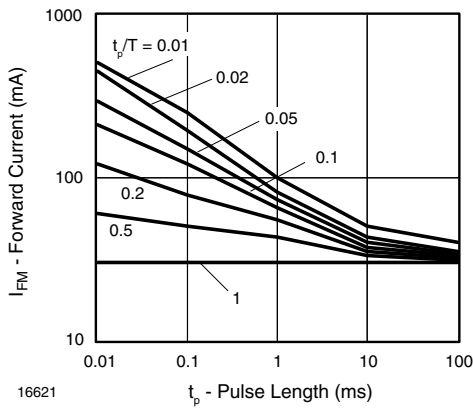


Fig. 2 - Forward Current vs. Pulse Length

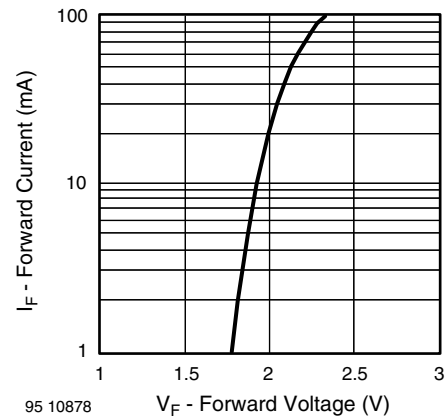


Fig. 5 - Forward Current vs. Forward Voltage

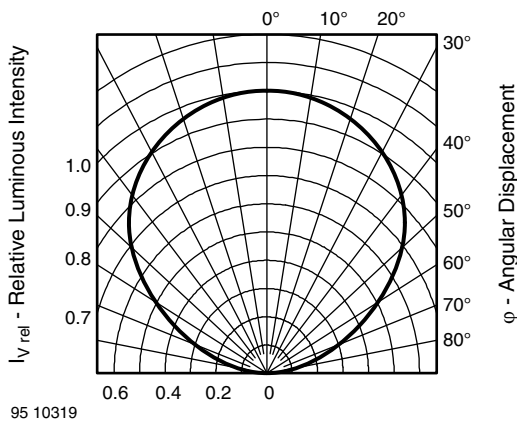


Fig. 3 - Relative Luminous Intensity vs. Angular Displacement

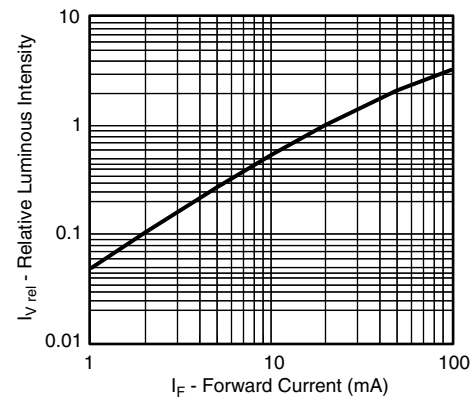


Fig. 6 - Relative Luminous Intensity vs. Forward Current

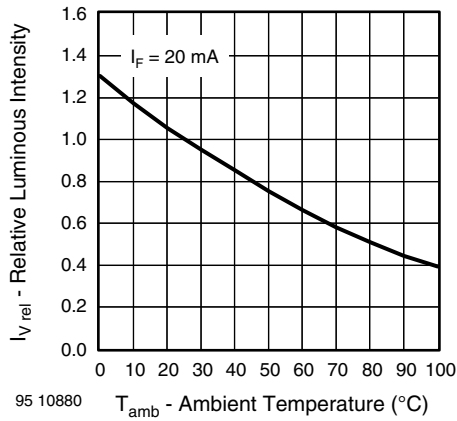


Fig. 7 - Relative Luminous Intensity vs. Ambient Temperature

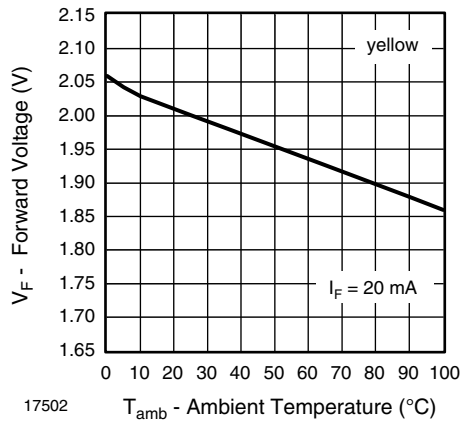


Fig. 8 - Forward Voltage vs. Ambient Temperature

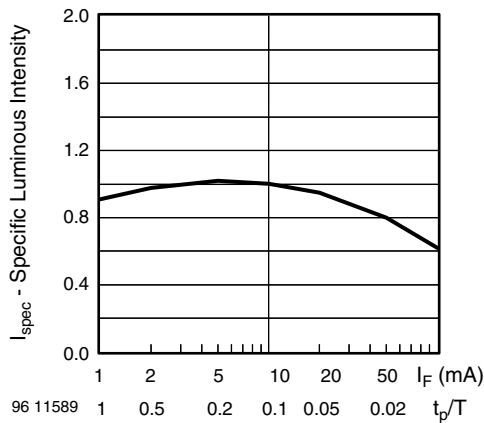
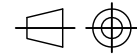
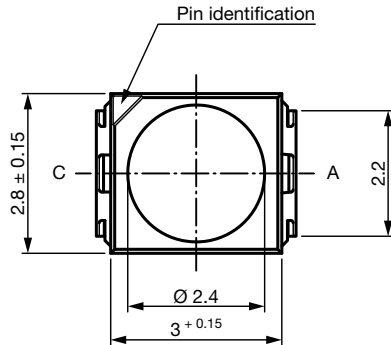
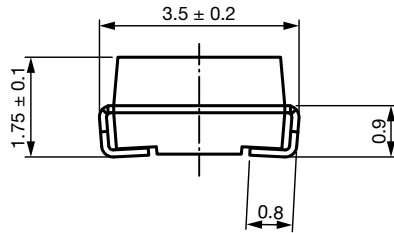


Fig. 9 - Relative Luminous Intensity vs. Forward Current/Duty Cycle

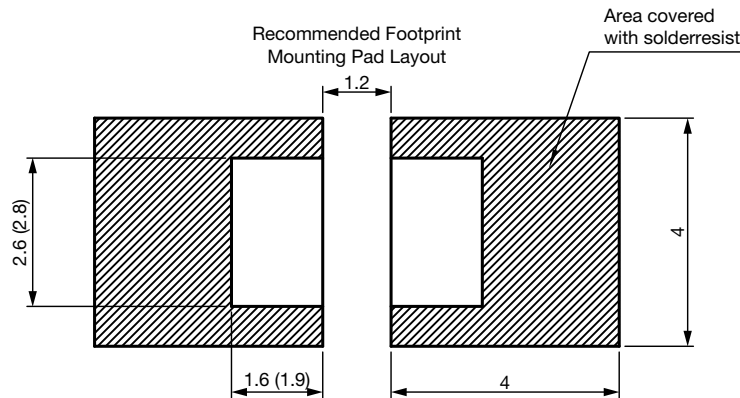

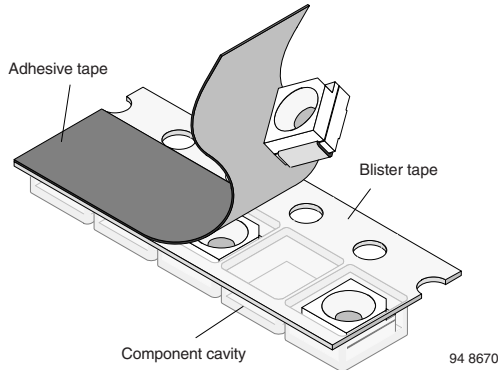

METHOD OF TAPING / POLARITY AND TAPE AND REEL

SMD LED (VLM3 - SERIES)

Vishay's LEDs in SMD packages are available in an antistatic 8 mm blister tape (in accordance with DIN IEC 40 (CO 564) for automatic component insertion. The blister tape is a plastic strip with impressed component cavities, covered by a top tape.

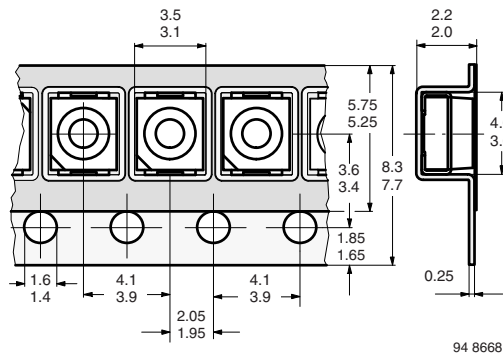


Fig. 10 - Tape Dimensions in mm for PLCC-2

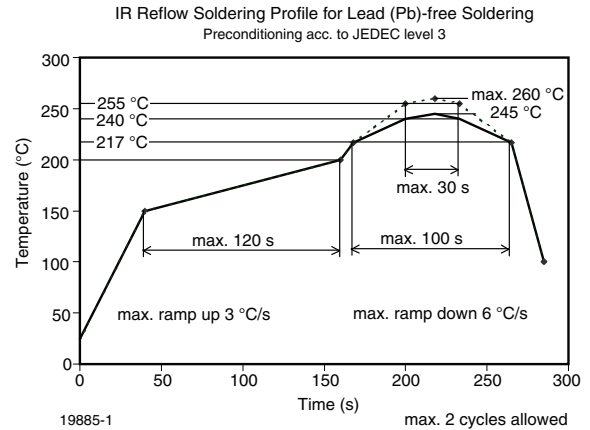


Fig. 12 - Vishay Lead (Pb)-free Reflow Soldering Profile (according to J-STD-020C)

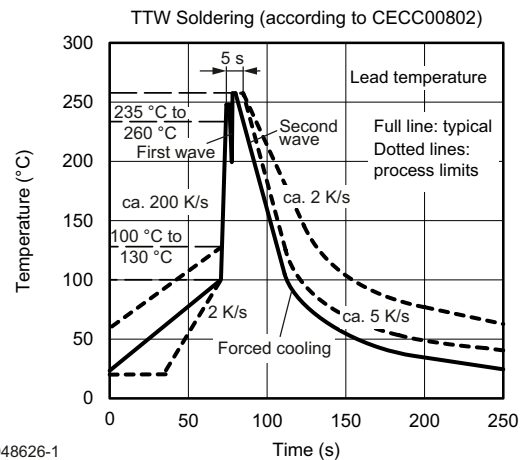


Fig. 13 - Double Wave Soldering of Opto Devices (all Packages)

REEL PACKAGE DIMENSION IN MILLIMETERS FOR SMD LEDs, TAPE OPTION GS08 (= 1500 PCS)

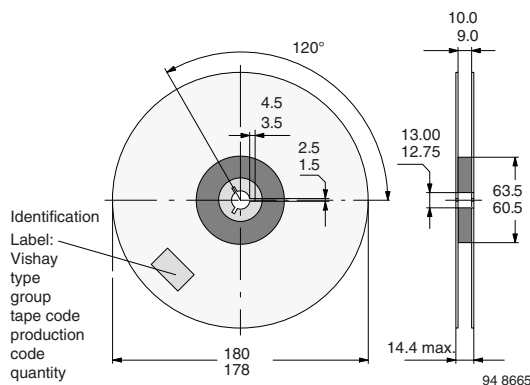
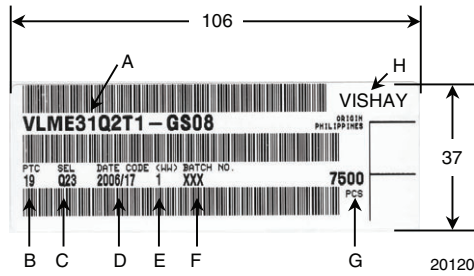


Fig. 11 - Reel Dimensions - GS08

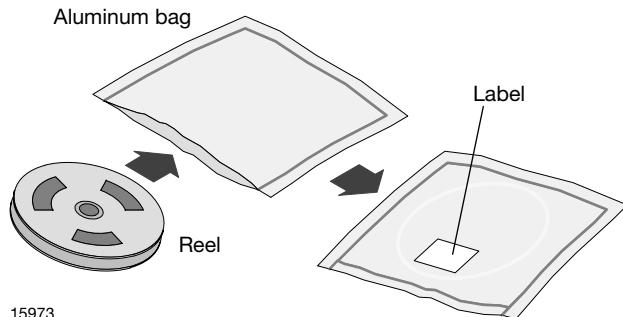

DRY PACKING

The reel is packed in an anti-humidity bag to protect the devices from absorbing moisture during transportation and storage.



FINAL PACKING

The sealed reel is packed into a cardboard box. A secondary cardboard box is used for shipping purposes.

RECOMMENDED METHOD OF STORAGE

Dry box storage is recommended as soon as the aluminum bag has been opened to prevent moisture absorption. The following conditions should be observed, if dry boxes are not available:

- Storage temperature 10 °C to 30 °C
- Storage humidity ≤ 60 % RH max.

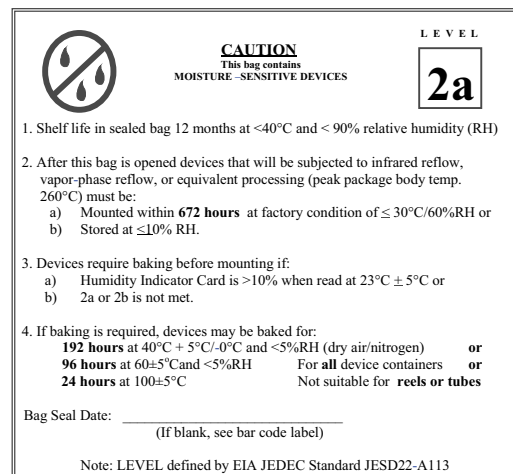
After more than 672 h under these conditions moisture content will be too high for reflow soldering.

In case of moisture absorption, the devices will recover to the former condition by drying under the following condition: 192 h at 40 °C + 5 °C / - 0 °C and < 5 % RH (dry air / nitrogen) or

96 h at 60 °C + 5 °C and < 5 % RH for all device containers or

24 h at 100 °C + 5 °C not suitable for reel or tubes.

An EIA JEDEC standard JESD22-A112 level 2a label is included on all dry bags.

ESD PRECAUTION

Proper storage and handling procedures should be followed to prevent ESD damage to the devices especially when they are removed from the antistatic shielding bag. Electrostatic sensitive devices warning labels are on the packaging.
