










Single Pulse Power, Junction-to-Ambient




V_{DS} - Drain-to-Source Voltage (V)







Normalized Thermal Transient Impedance, Junction-to-Ambient

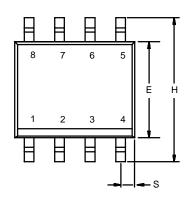


Normalized Thermal Transient Impedance, Junction-to-Foot
