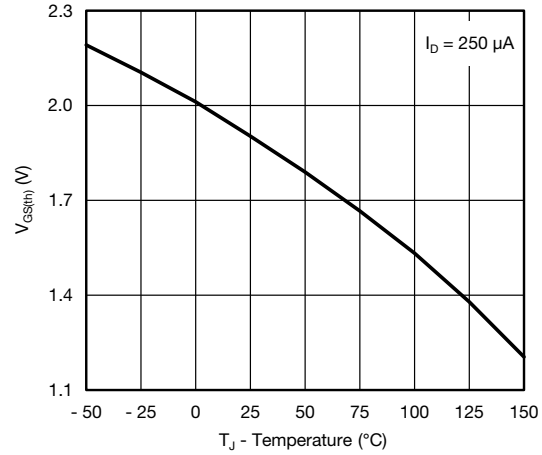

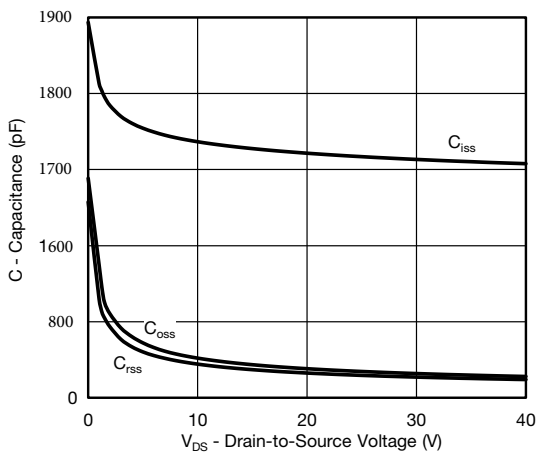

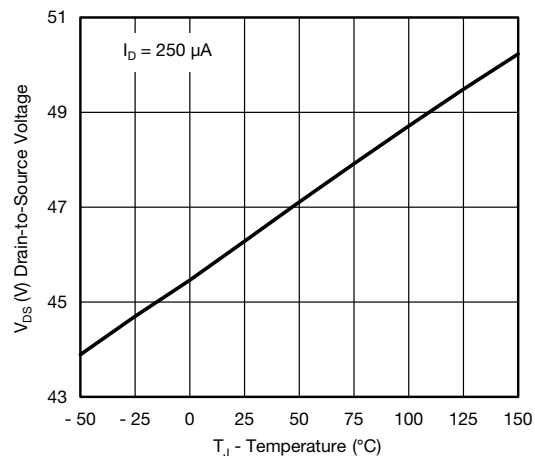
**Source-Drain Diode Forward Voltage**



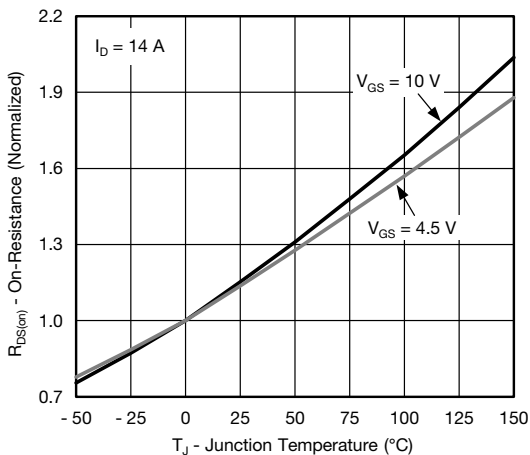

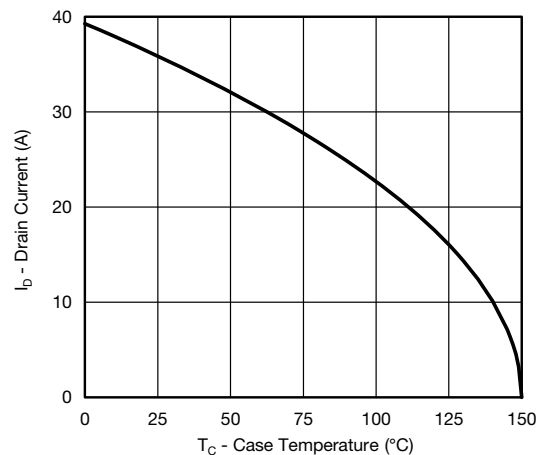

**Drain Source Breakdown vs. Junction Temperature**

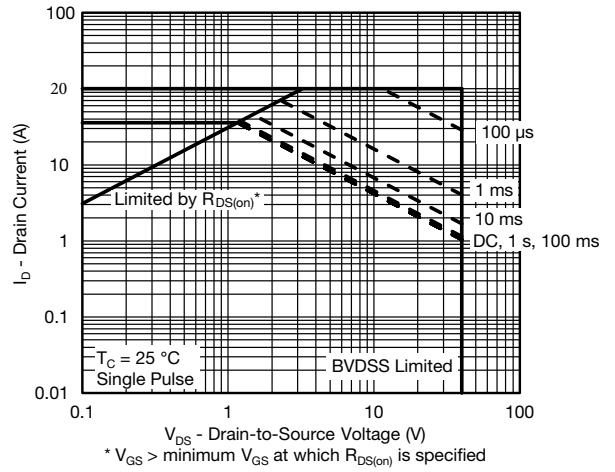
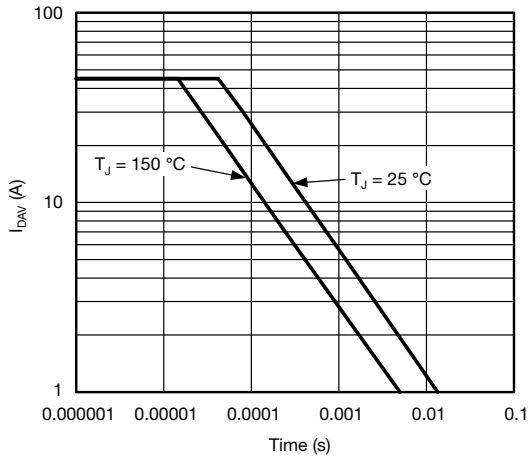


**On-Resistance vs. Junction Temperature**



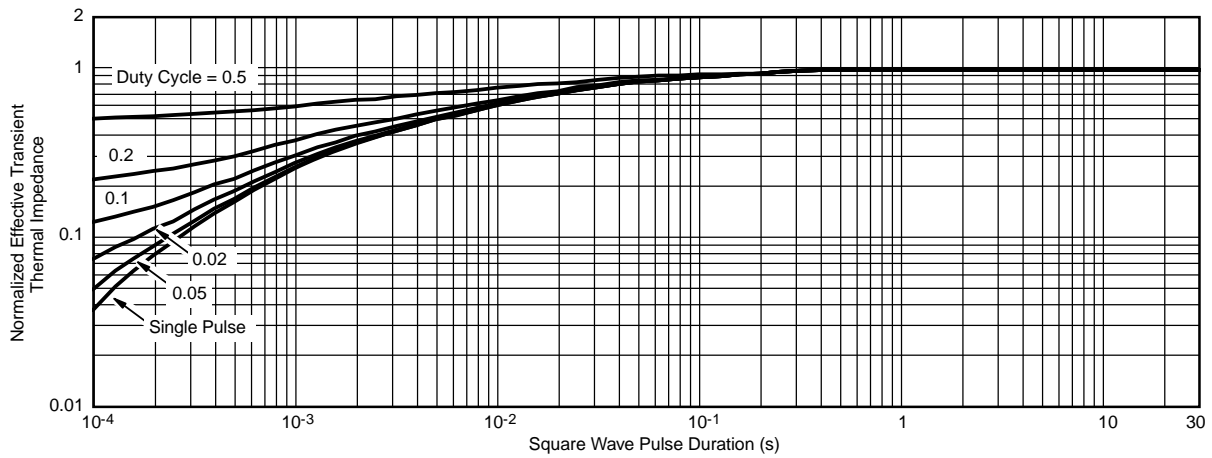

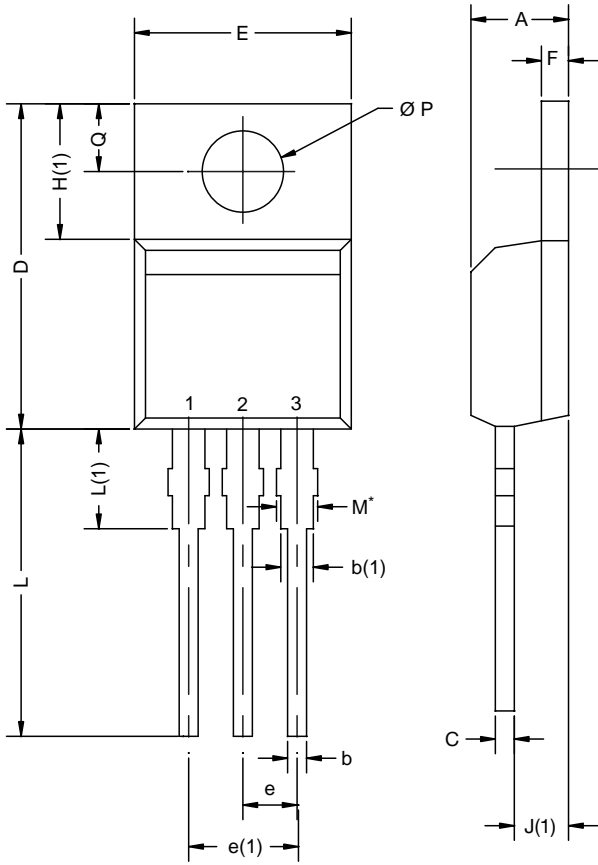
Single Pulse Avalanche Current Capability vs. Time
