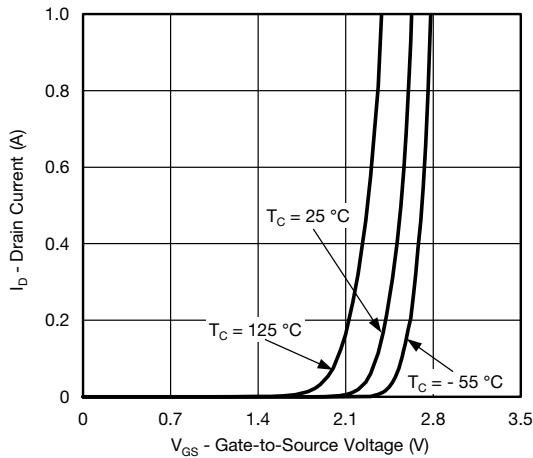

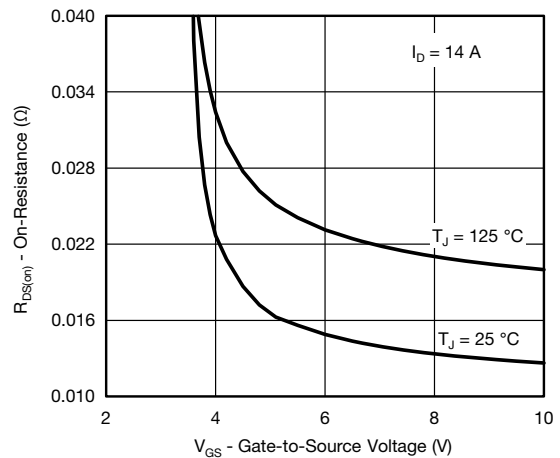

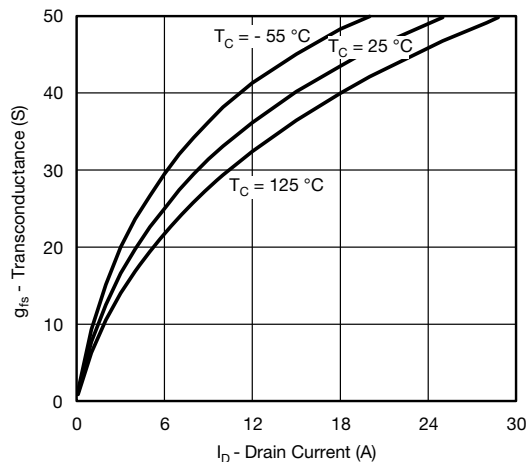
**On-Resistance vs. Drain Current**



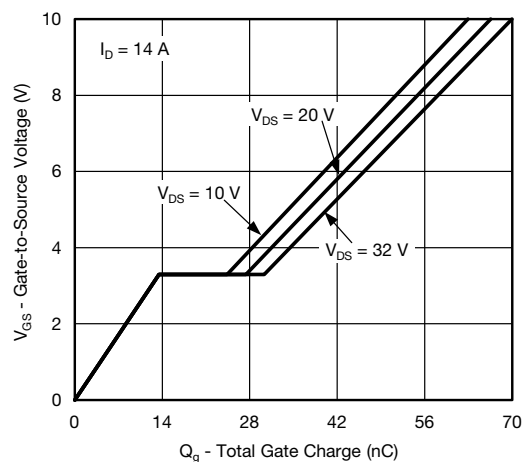

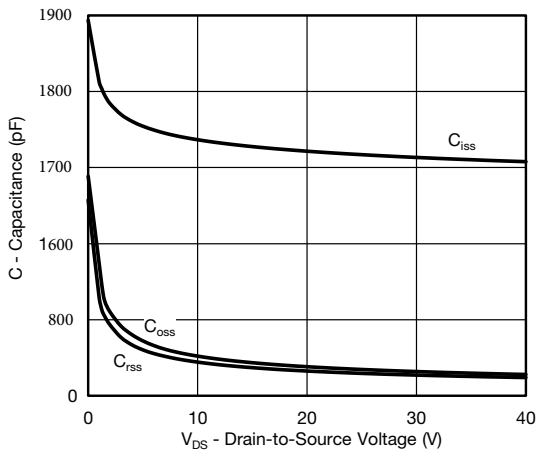

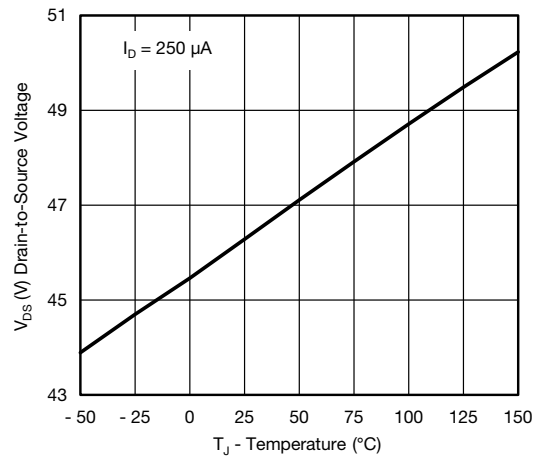

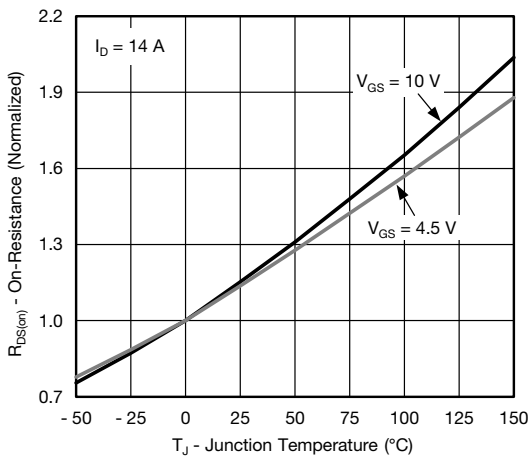

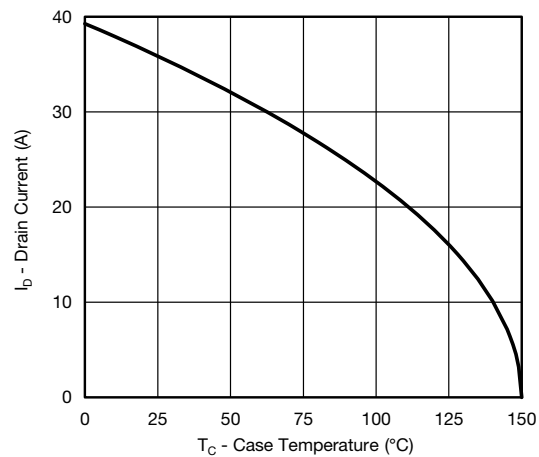

**Drain Source Breakdown vs. Junction Temperature**

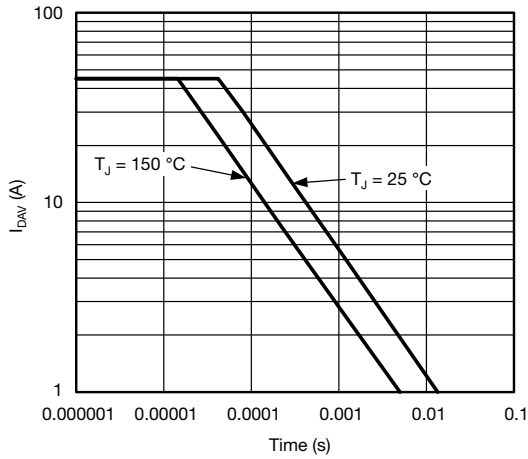

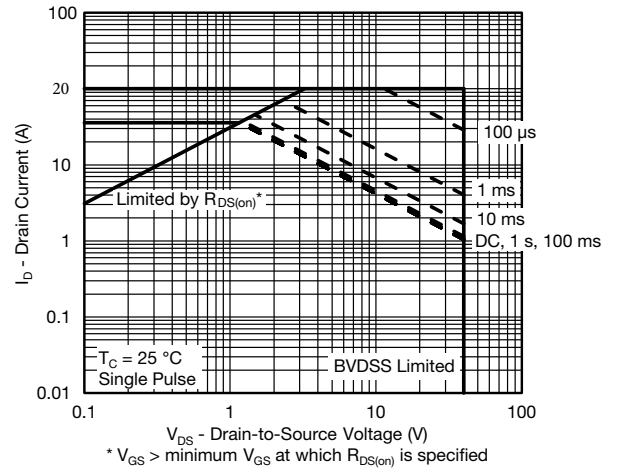

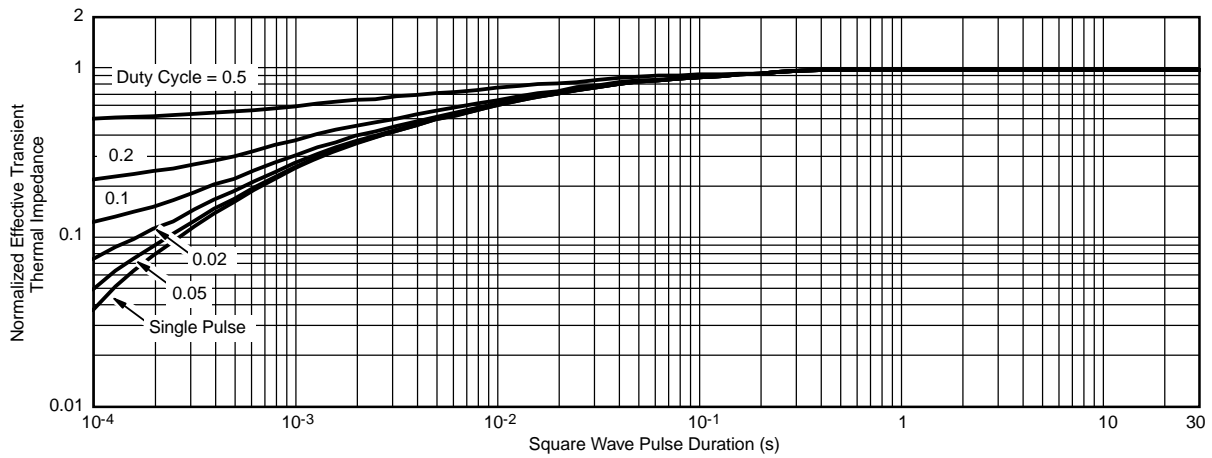

Single Pulse Avalanche Current Capability vs. Time

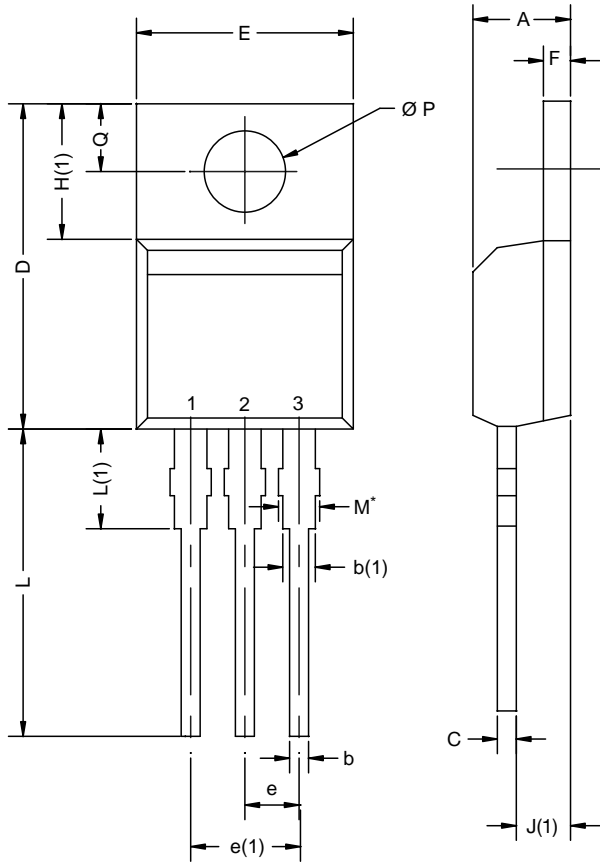


Safe Operating Area
