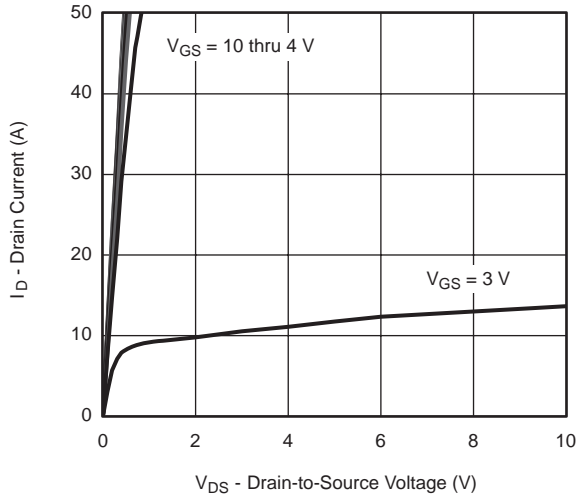

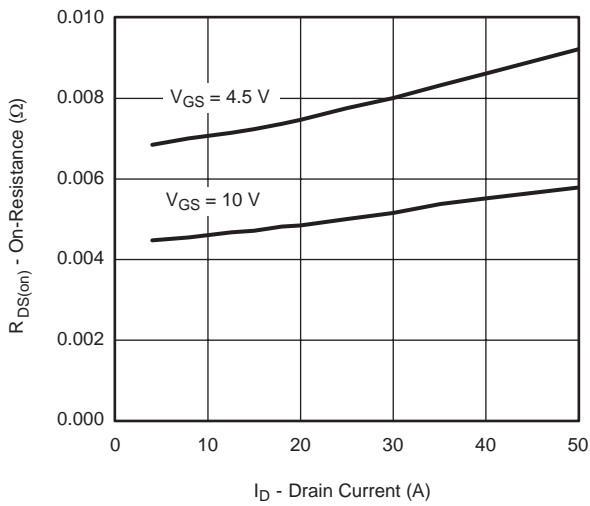

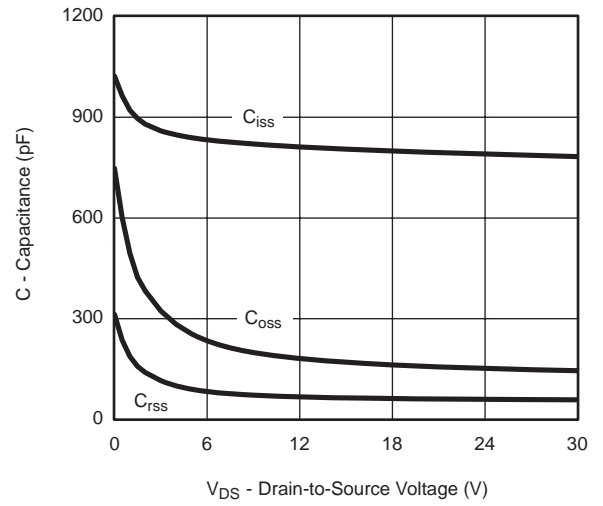

Capacitance

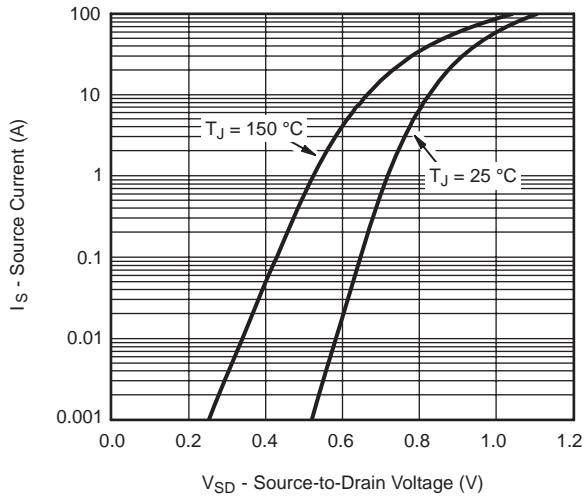


Gate Charge

Threshold Voltage



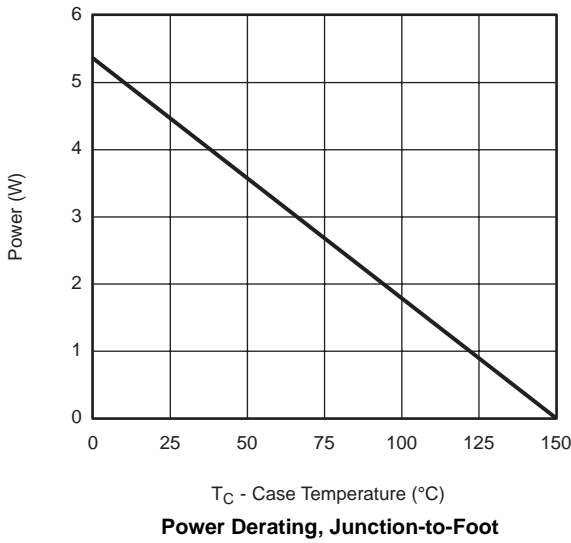
Single Pulse Power, Junction-to-Ambient
