




#### Radiation Characteristics 8), 9)

 $I_{e,rel} = f(\phi)$ 




#### Forward current <sup>8), 9)</sup>




### Relative Radiant Intensity 8), 9)






#### Max. Permissible Forward Current





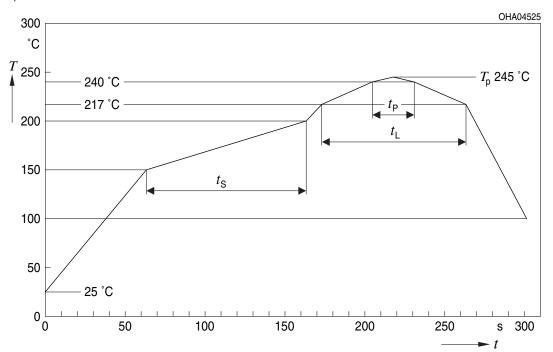

Taping <sup>10)</sup>



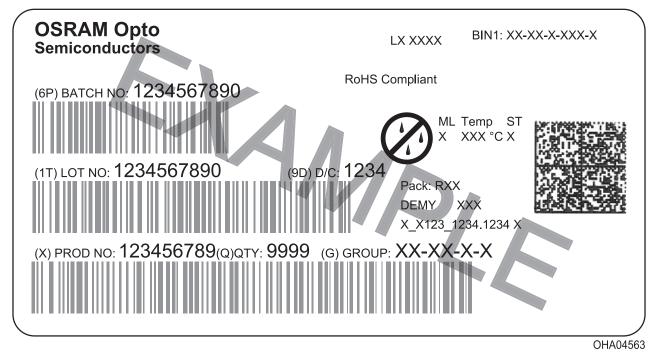


### Tape and Reel <sup>11)</sup>






#### **Barcode-Product-Label (BPL)**

#### **Notes**


