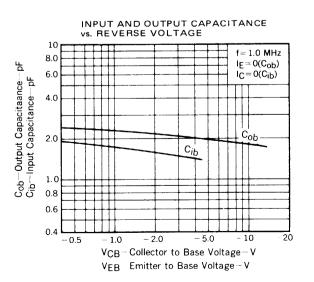


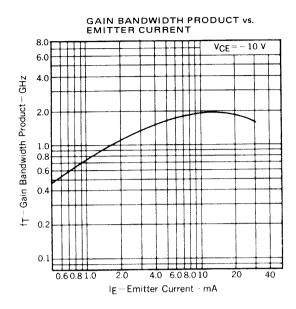


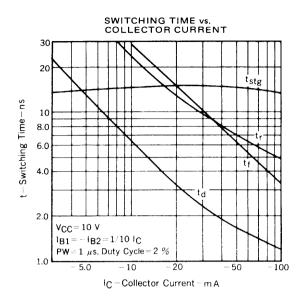




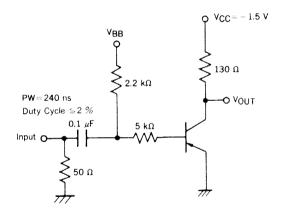




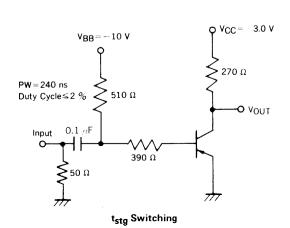


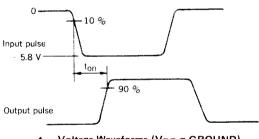


SWITCHING TIME TEST CIRCUIT

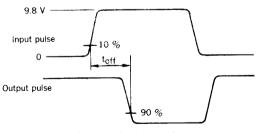

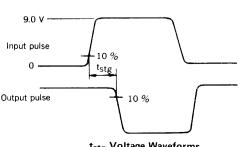




ton Voltage Waveforms (VBB = GROUND)
