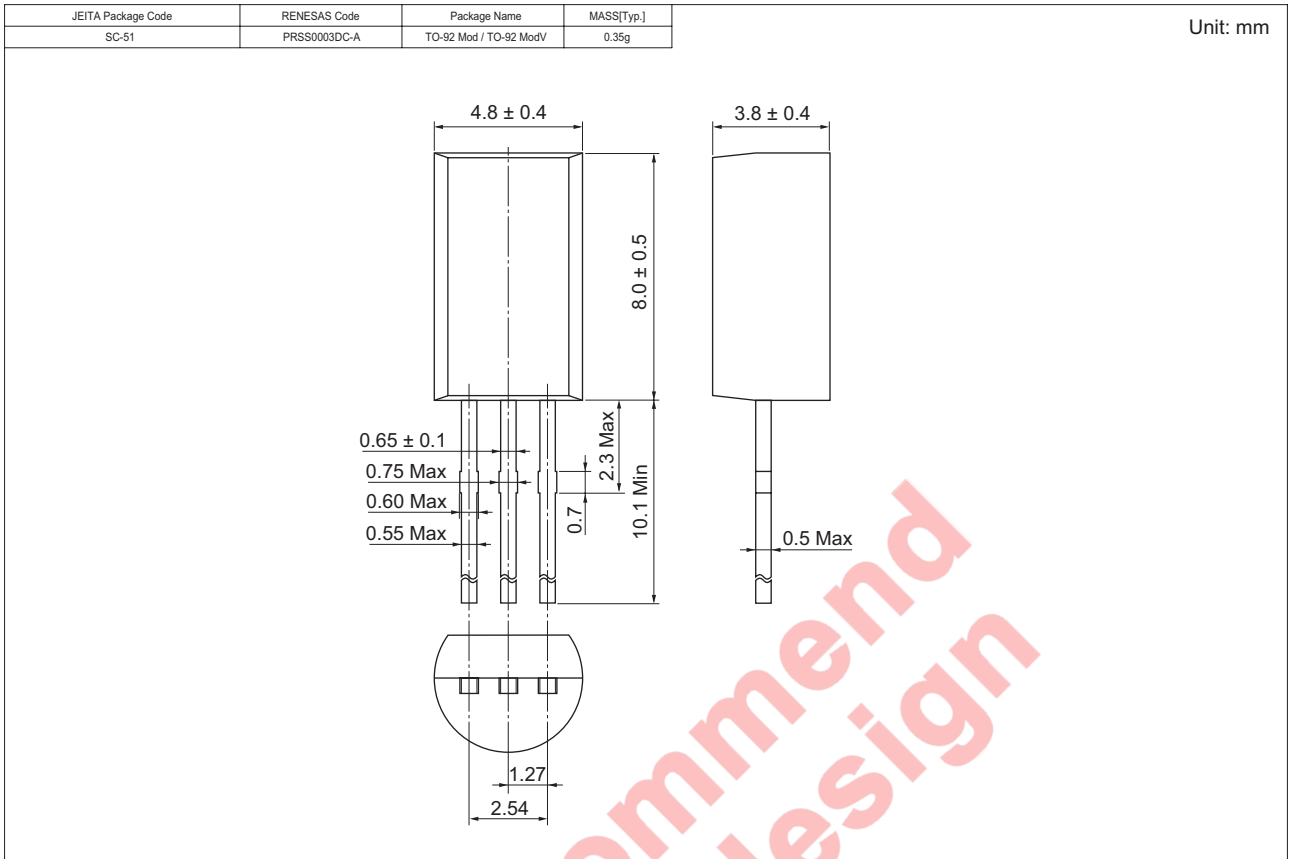
Main Characteristics
