






TYPICAL CHARACTERISTICS (25 C, unless otherwise noted)




Source-Drain Diode Forward Voltage




V_{GS} - Gate-to-Source Voltage (V)

Single Fulse Fower





Normalized Thermal Transient Impedance, Junction-to-Foot






