







Forward Diode Voltage vs. Temperature










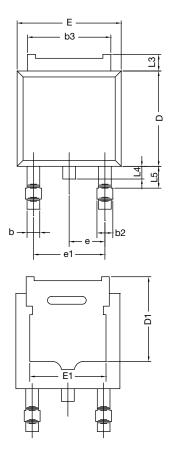

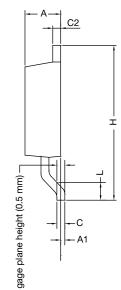

TO-252AA CASE OUTLINE






