

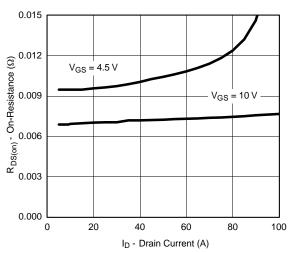

On-Resistance vs. Junction Temperature









Maximum Drain Current vs. Ambient Temperature




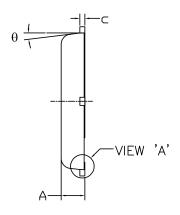
Normalized Thermal Transient Impedance, Junction-to-Case






DFN5x6_8L_EP1_P PACKAGE OUTLIN










<u>VIEW 'A'</u> (SCALE 5:1)
