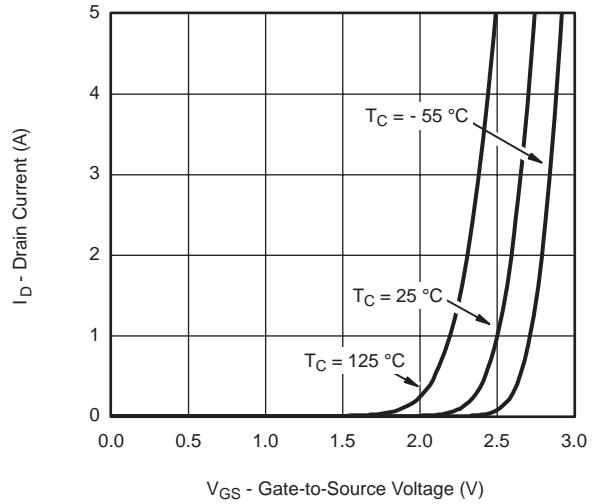

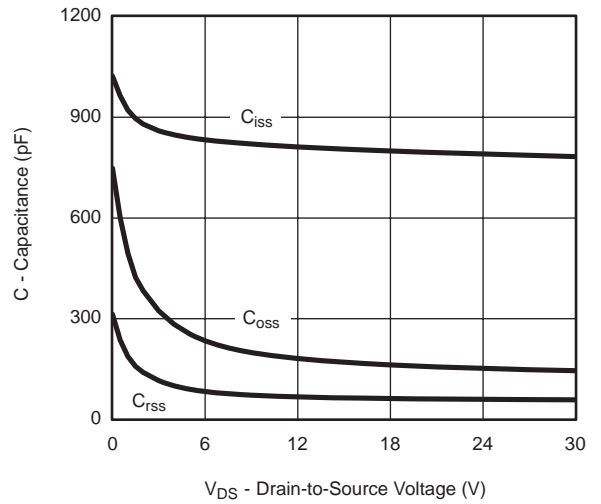

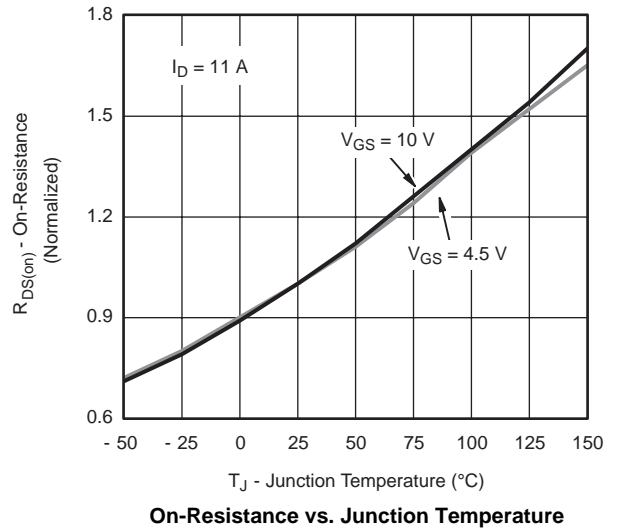
On-Resistance vs. Drain Current and Gate Voltage

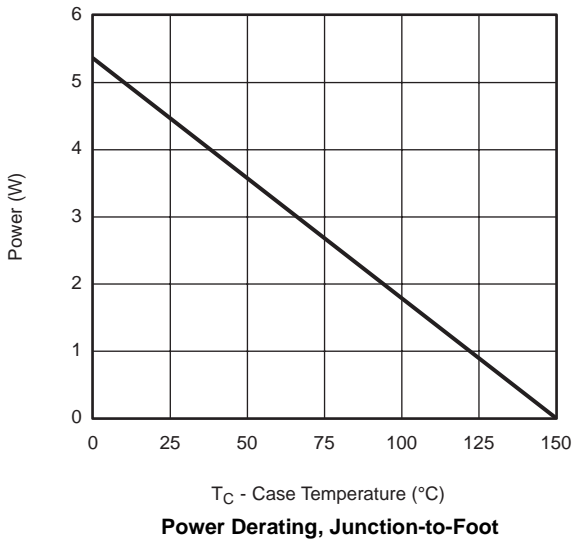
Single Pulse Power, Junction-to-Ambient
