


TYPICAL CHARACTERISTICS ($T_A = 25 \text{ °C}$, unless otherwise noted)











T_J - Temperature (°C) Threshold Voltage



On-Resistance vs. Junction Temperature








Drain Source Breakdown vs. Junction Temperature





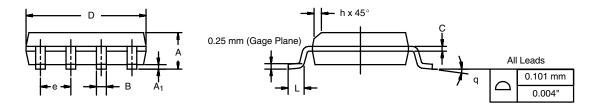


