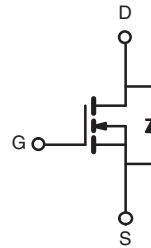

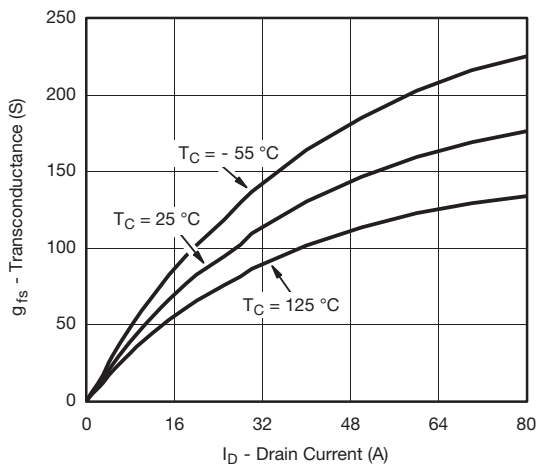

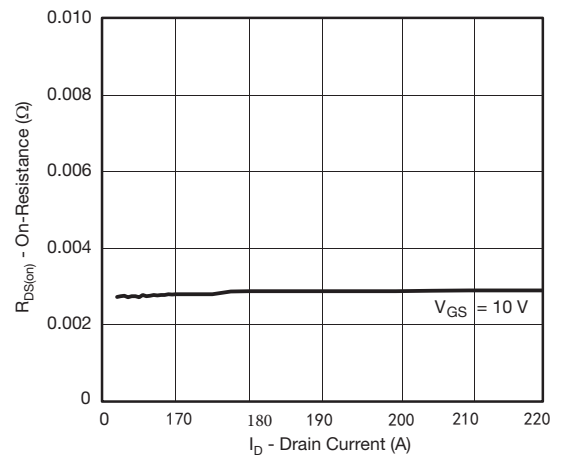

**On-Resistance vs. Drain Current**

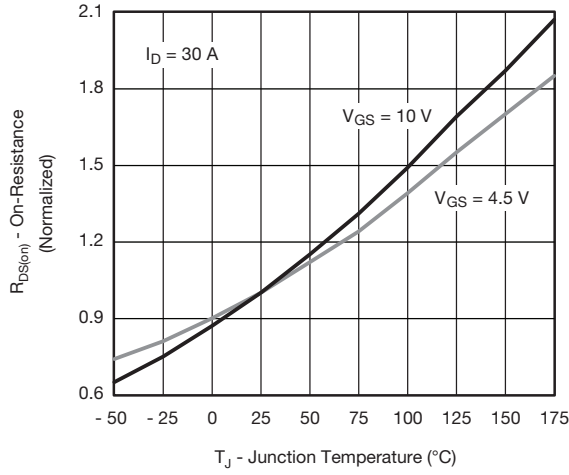

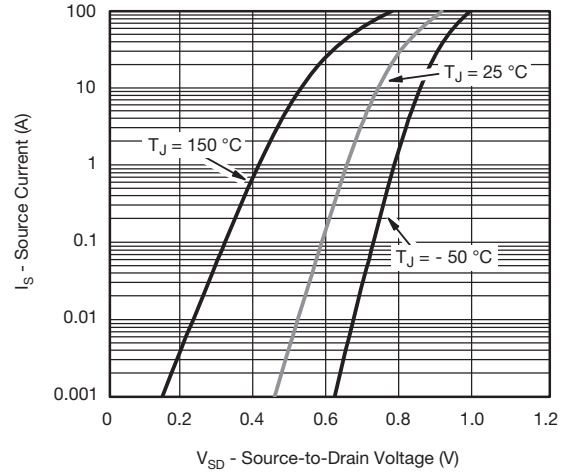

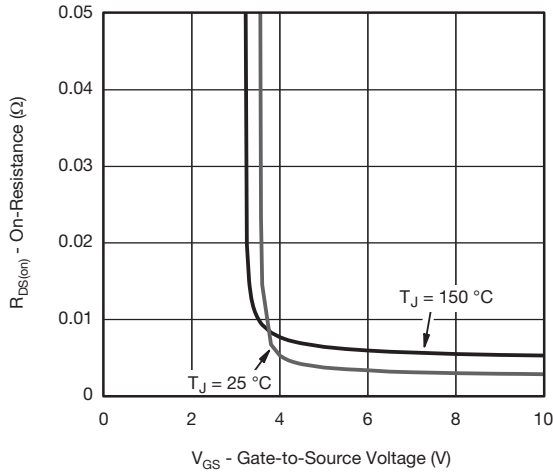

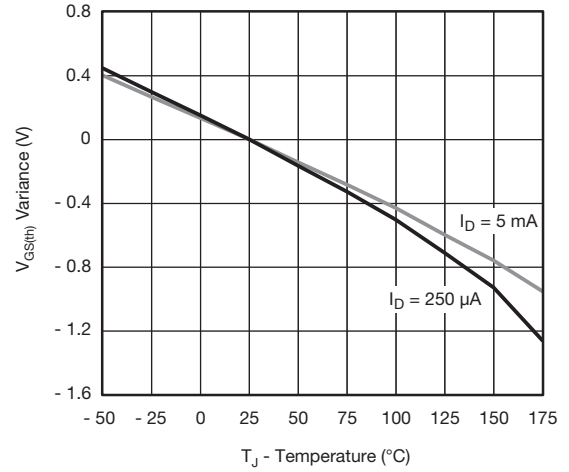
**On-Resistance vs. Junction Temperature**



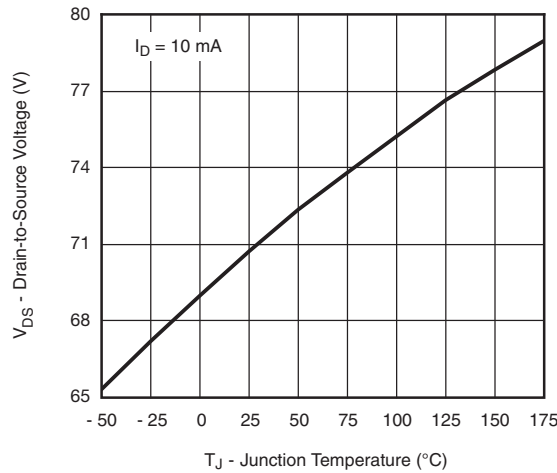
**Source Drain Diode Forward Voltage**

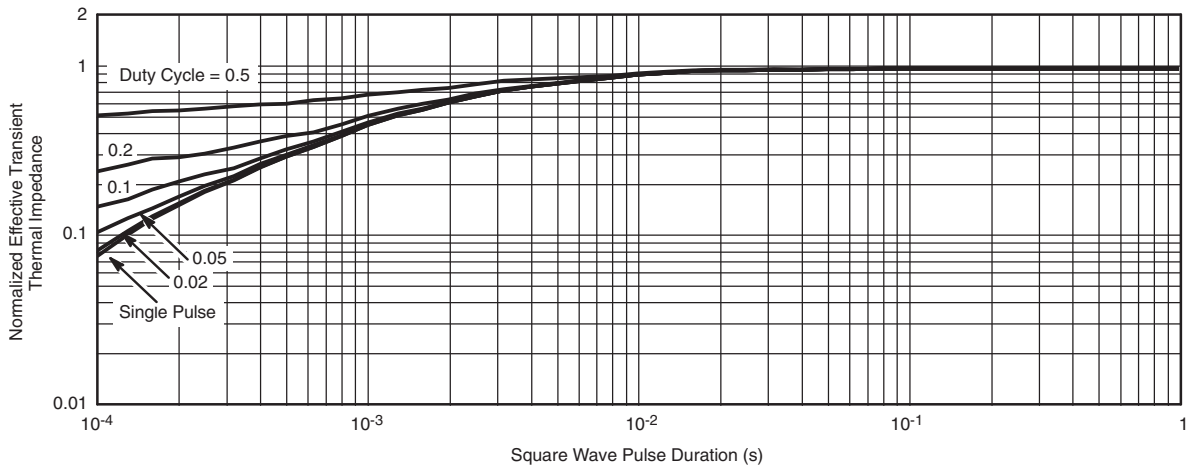

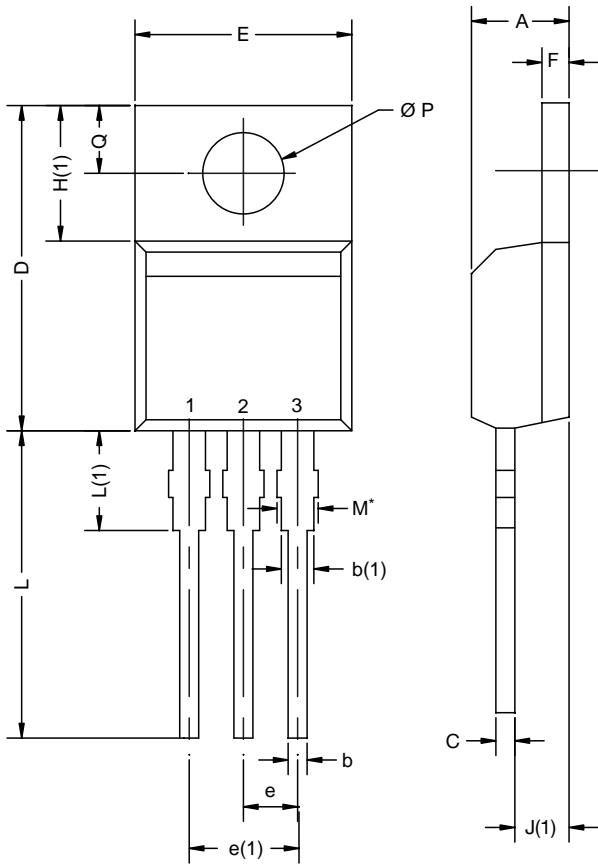


**Normalized Thermal Transient Impedance, Junction-to-Case**
