
#### TYPICAL CHARACTERISTICS (25 °C, unless otherwise noted)













 $R_{DS(on)}$  vs.  $V_{GS}$  vs. Temperature




Forward Diode Voltage vs. Temperature



















<u>VIEW 'A'</u> (SCALE 5:1)
