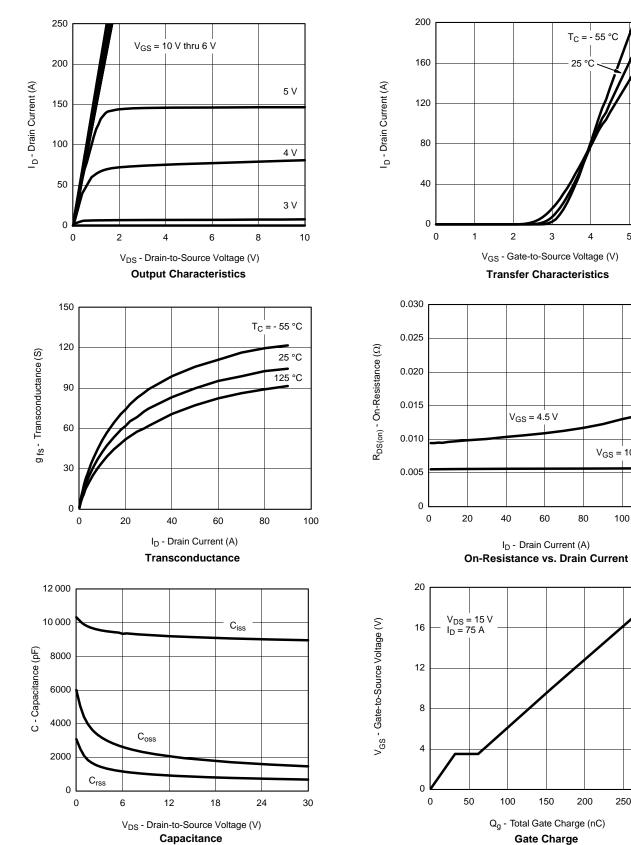

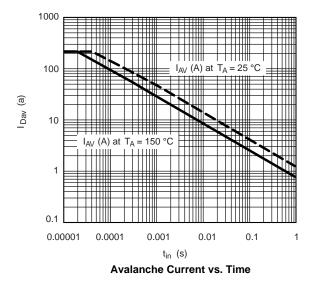

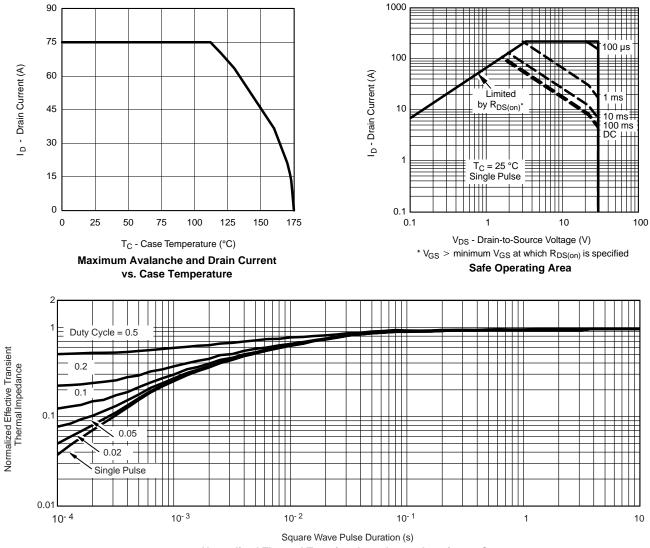








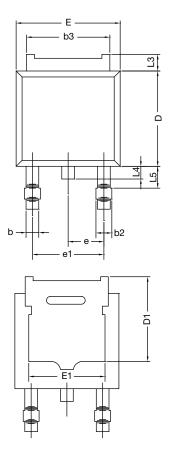
THERMAL RATINGS
