
Relative Spectral Emission⁴⁾


Radiation Characteristics⁴⁾




Relative Partial Flux⁴⁾






Chromaticity Coordinate Shift ⁴⁾






Relative Luminous Flux⁴⁾


Chromaticity Coordinate Shift ⁴⁾

 ΔCx , $\Delta Cy = f(T_i)$; I_F = 350 mA; full spectral range




Chromaticity Coordinate Shift ⁴⁾

 ΔCx , $\Delta Cy = f(T_i)$; I_F = 350 mA; within λ = 500 ... 600 nm






