





B2:  $P_{opt} = f(\lambda)$ ;  $T_{case} = 25^{\circ}C$ 




**Beam Divergence** <sup>7), 8)</sup>  $P_{opt} = f(\Theta); T_{case} = 25^{\circ}C$ 






#### **Optical Output Power** <sup>7), 8)</sup>

B1:  $P_{opt} = f(IF); T_{case} = 25^{\circ}C$ 




#### **Optical Output Power** <sup>7), 8)</sup>

B2:  $P_{opt} = f (IF); T_{case} = 25^{\circ}C$ 




# Opt. Power / Forward Voltage 7), 8)

B1:  $V_F = f(I_F)$ ;  $T_{case} = 25^{\circ}C$ 








# **Threshold Current**

Operating the laser diode above the maximum rating even for very short periods of time can damage the laser diode or reduce its lifetime. The laser diode must be operated with a suitable power supply with minimized electrical noise. The laser diode is very sensitive to electrostatic discharge (ESD). Proper precautions must be taken.

#### b) Mounting instructions

In order to maintain the lifetime of the laser diode proper heat management is essential. Due to the design of the laser diode heat is dissipated only through the base plate of the diode's body. A proper heat conducting interconnection between the diodes base plate and the heat sink must be maintained.
