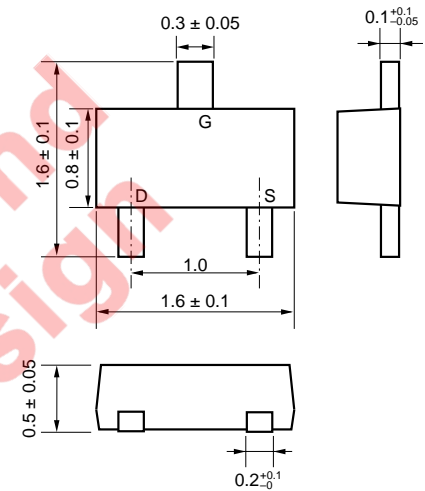

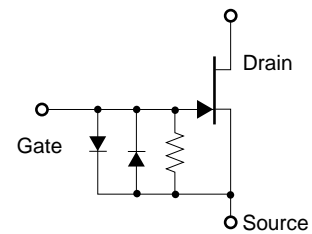
**PACKAGE DRAWING (Unit: mm)**

**NOISE VOLTAGE TEST CIRCUIT**

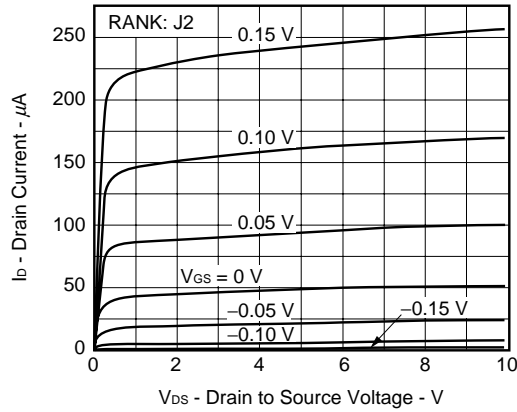

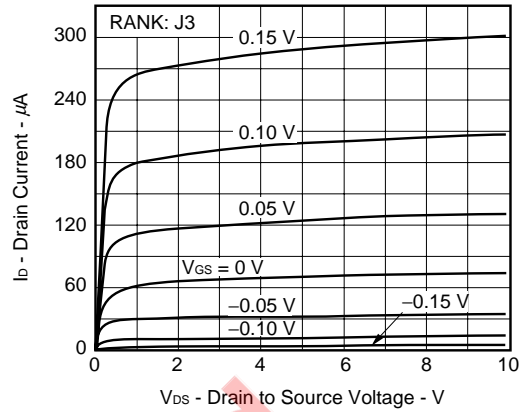

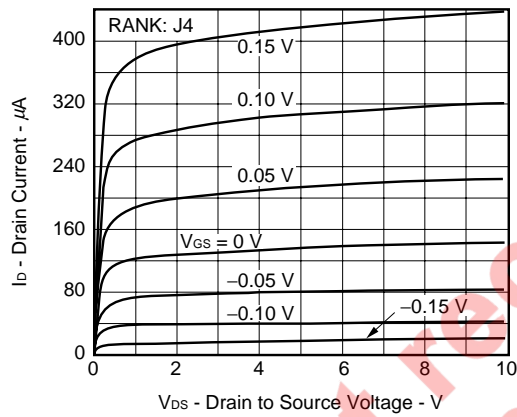
DRAIN CURRENT vs.  
DRAIN TO SOURCE VOLTAGE



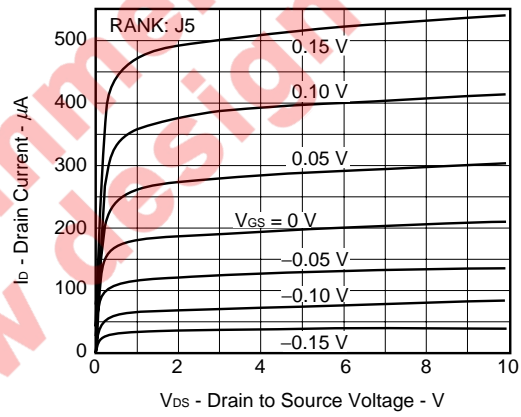
DRAIN CURRENT vs.  
DRAIN TO SOURCE VOLTAGE



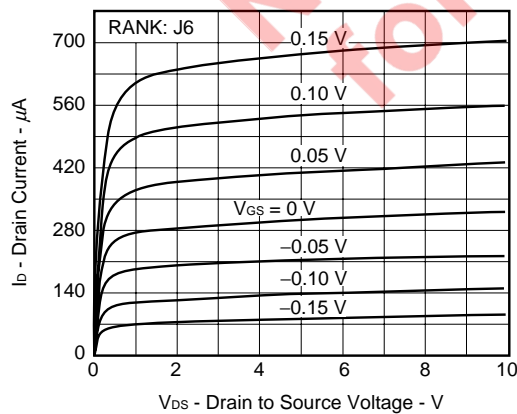
DRAIN CURRENT vs.  
DRAIN TO SOURCE VOLTAGE



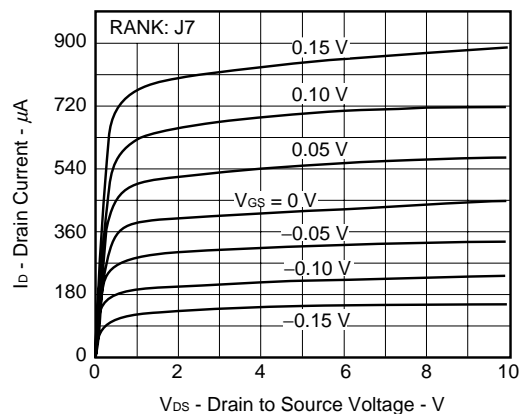
DRAIN CURRENT vs.
