



PACKAGE DRAWING (Unit: mm)








### TEST CIRCUIT 1 SWITCHING TIME




#### TEST CIRCUIT 2 GATE CHARGE













GATE CUT-OFF VOLTAGE vs.

CHANNEL TEMPERATURE




FORWARD TRANSFER ADMITTANCE vs. DRAIN CURRENT



 $R^{\text{DS}(\text{on})}$  - Drain to Source On-state Resistance -  $m\Omega$ 



DRAIN TO SOURCE ON-STATE RESISTANCE vs. CHANNEL TEMPERATURE


