



FREQUENCY CHARACTERISTICS



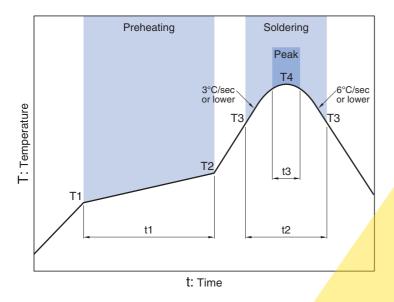
