## 3 Description

This single inverter gate is operational at 0.8-V to 2.7-V  $V_{CC}$ , but is designed specifically for 1.65-V to 1.95-V  $V_{CC}$  operation.

The SN74AUC1G04 performs the Boolean function  $Y = \overline{A}$ .

NanoFree<sup>™</sup> package technology is a major breakthrough in IC packaging concepts, using the die as the package.


This device is fully specified for partial-power-down applications using  $I_{\text{off}}$ . The  $I_{\text{off}}$  circuitry disables the ouput, preventing damaging current backflow through the device when it is powered down.










#### YZP Package 5-Pin DSBGA Bottom View






